An Act relative to criminal manufacture and possession of certain weapons.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1.

2 Chapter 269 of the General Laws shall be amended by inserting a new section:

3 10L: Criminal Manufacture and Transfer of Weapons

4 Any prohibited person who illegally manufactures a firearm, rifle, shotgun, machine gun  
5 or sawed-off shotgun shall be punished by imprisonment in the state prison for not or more than  
6 5 years.

7 Any person who illegally manufactures a firearm, rifle, shotgun, machine gun or sawed-  
8 off shotgun and transfers or supplies said weapon to a prohibited person within or without of the  
9 Commonwealth shall be punished by imprisonment in the state prison for not or more than 10  
10 years.

11           Whoever transports an illegally manufactured firearm, rifle, shotgun, machine gun or  
12 sawed-off shotgun into the commonwealth to use the weapon for the commission of criminal  
13 activity shall be punished by imprisonment in the state prison for not or more than 10 years.

14           Whoever, while in the commission of a felony, has in his possession or under his control  
15 an illegally manufactured firearm, rifle, shotgun, machine gun or sawed-off shotgun shall be  
16 punished by imprisonment in the state prison for not less than not more than 10 years.

17           Whoever transports an illegally manufactured firearm, rifle, shotgun, machine gun or  
18 sawed-off shotgun into the commonwealth to unlawfully distribute, sell or transfer possession of  
19 the weapon to a prohibited person, as defined in section 131 of chapter 140, shall be punished by  
20 imprisonment in the state prison for not more than 20 years.

21           Whoever transports an illegally manufactured firearm, rifle, shotgun, machine gun or  
22 sawed-off shotgun into the commonwealth to unlawfully distribute, sell or transfer the weapon to  
23 a prohibited person, as defined in section 131 of chapter 140, and if the weapon is subsequently  
24 used to commit severe bodily injury or murder, shall be punished by imprisonment in the state  
25 prison for up to life imprisonment.

26           Upon conviction of this section, the courts shall notify the appropriate federal authorities  
27 of potential violations of federal manufacturing and transfer laws.
