An Act relative to Covid-19 complications for public safety employees.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 41 shall be amended by adding the following section:

3 Section 100C; Upon written application by any of its police officers or firefighters retired  
4 either before or after the acceptance of this section; or in the event of the death of any such  
5 police officer or firefighter, upon written application by his widow or, if he leaves no widow, by  
6 his next of kin, any municipality shall indemnify such police officer or firefighter or, in the event  
7 of his death, his widow, or if he leaves no widow, his next of kin, for all reasonable hospital,  
8 medical and surgical, chiropractic, nursing, pharmaceutical, prosthetic and other related expenses  
9 and reasonable charges incurred by such police officer or firefighter after his retirement relating  
10 to ongoing treatment or complications relating to Covid-19 or its variant contracted as a work-  
11 related illness; provided, however, that no person shall be indemnified under this section unless  
12 a majority of the members of a panel consisting of (a) the chairman of the retirement board of the

13 city or town, (b) the city solicitor, town counsel or other officer having similar duties or a person  
14 designated in writing by such solicitor, counsel, or officer to act for him, and (c) such physician  
15 selected by agreement of the city or town manager and the retiree's physician, upon receipt from  
16 the applicant of due proof, certify:—(1) that the expenses for which indemnification is sought  
17 were the natural and proximate result of Covid-19 or its variant contracted as a work-related  
18 illness; (2) that such expenses were incurred after the acceptance of this section; (3) that the  
19 hospital, medical and surgical, chiropractic, nursing, pharmaceutical, and/or prosthetic to which  
20 such expenses relate were rendered within six months before the filing of the application; (4) that  
21 such expenses are reasonable under all the circumstances.

22           Provided further that this section shall additionally cover State Police officers through the  
23 Executive Office of Public Safety.
