An Act relative to harbormasters.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1: Paragraph (g), and further under the subparagraph title of "Group 2", of  
2 section 3 of chapter 32 of the General Laws, as appearing in the most recent edition, is hereby  
3 amended by inserting after the words, "Cushing hospital" the following words:- "employees of a  
4 city or town who are employed as Harbormasters and assistant Harbormasters, and appointed  
5 pursuant to chapter  
6           102 of the General Laws."
