Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Subsection (p) of section 6 of chapter 62 of the General Laws, as appearing 2 in the 2018 Official Edition, is hereby amended by adding, in line 769, after the words "as 3 amended" the following words:- ", or private nonprofit trust compliant with chapter 203 4 organized for the purposes of land conservation, which is authorized to do business in the 5 commonwealth, and which has tax-exempt status as a nonprofit charitable organization as 6 described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. 7 SECTION 2. Said subsection (p) of said section 6 of said chapter 62, as so appearing, is 8 hereby amended by striking out, in line 835, the figure "\$2,000,000" and inserting in place 9 thereof the following figure:- "\$3,000,000". 10 SECTION 3. Said subsection (p) of said section 6 of said chapter 62, as so appearing, is
 - hereby amended by striking out, in line 835, the figure "\$3,000,000" and inserting in place thereof the following figure:- "\$4,000,000".

Section 38AA of chapter 63, as so appearing, is hereby amended by adding, in line 29, after the words "as amended" the following words:-, or a private nonprofit trust 18 compliant with chapter 203 organized for the purposes of land conservation, which is authorized 19 to do business in the commonwealth, and which has tax-exempt status as a nonprofit charitable 20 organization as described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended.
