An Act allowing for the deduction of business interest.

*Whereas*, The deferred operation of this act would tend to defeat its purpose, which is to decouple from certain provisions of the federal Tax Cuts and Jobs Act that took effect for tax years beginning after December 31, 2017, therefore it is hereby declared to be an emergency law, necessary for the immediate preservation of the public convenience.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of chapter 62 of the General Laws is hereby amended by striking  
2 out subsection (c) and inserting in place thereof the following subsection: -

4           (c) “Code”, the Internal Revenue Code of the United States, as amended on January 1,  
5 2005 and in effect for the taxable year; but Code shall mean the Code as amended and in effect  
6 for the taxable year for sections 62(a)(1), 72, 105, 106, 139C, 223, 274(m), 274(n), 401 through  
7 420, inclusive, 457, 529, 529A, 530, 951, 951A, 959, 961, 3401 and 3405 but excluding sections

8 402A and 408(q), and provided further that for purposes of determining the amount of business  
9 interest deductible under this chapter, the provisions of section 163(j) of the Code shall not  
10 apply.

12 SECTION 2. Section 1 of chapter 63 of the General Laws is hereby amended by striking  
13 out the definition of “Code” therein and inserting in place thereof the following definition: -

15 “Code”, the Internal Revenue Code of the United States, as amended and in effect for the  
16 taxable year, unless otherwise provided; for sections 163(j), 381(c)(20), 382(d)(3) and 382(k)(1),  
17 Code shall mean the Code as amended and in effect for tax years beginning before January 1,  
18 2018.

20 SECTION 3. Section 30 of said chapter 63 is hereby amended by striking out the first  
21 sentence of paragraph 4 and inserting in place thereof the following sentence: -

22 “Net income”, gross income less the deductions, but not credits, allowable under the  
23 provisions of the Federal Internal Revenue Code, as amended and in effect for the taxable year;  
24 provided, however, that for sections 163(j), 381(c)(20), 382(d)(3) and 382(k)(1), Code shall  
25 mean the Code as amended and in effect for tax years beginning before January 1, 2018, and  
26 provided further that any deduction otherwise allowable which is allocable, in whole or in part,  
27 to one or more classes of income not included in a corporation’s taxable net income, as  
28 determined under subsection (a) of section 38, shall not be allowed.

29           SECTION 4. This act shall be effective for taxable years beginning after December 31,  
30   2017.
