Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 1 of Chapter 62 of the General Laws, as appearing in the 2018
- 2 Official Edition, is hereby amended, in subsection (c), by inserting after the figure "106," the
- 3 following figures:- 132(f)
- 4 SECTION 2. Section 3 of Chapter 62 of the General Laws, as appearing in the 2018
- 5 Official Edition, is hereby amended, in subparagraph (15) of subsection (b), by striking the
- 6 words "weekly or monthly transit commuter passes for Massachusetts Bay Transit Authority
- 7 transit, bus, commuter rail or commuter boat" and inserting in its place the following:-
- 8 "Massachusetts Bay Transit Authority or Regional Transit Authority transit, bus, commuter rail
- 9 or commuter boat fares, or for a bikeshare membership or for a bicycle including electric bikes,
- 10 bicycle improvements, repair, and storage,"

- SECTION 3. Section 3 of Chapter 62 of the General Laws, as appearing in the 2018
- 12 Official Edition, is hereby amended, in subparagraph (15) of subsection (b), by striking the
- figure \$150 each time it appears and inserting in place thereof the following figure:- "\$50".
