#### The Commonwealth of Alassachusetts

In the One Hundred and Ninety-Second General Court (2021-2022)

An Act relative to refrigeration technicians.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Section 81 of Chapter 146 of the General Laws, as appearing in the 2018
- 2 Official Edition, is hereby amended by inserting after the definition of "Registered", the
- 3 following new definition:-
- 4 "Residential/Light Commercial Refrigeration", the installation, repair, replacement,
- 5 maintenance of any refrigerant containing part of any refrigerant system of less than ten ton
- 6 capacity.
- 7 SECTION 2. Said Chapter 146 is hereby further amended by inserting after section 82,
- 8 the following new section:-
- 9 Section 82A. The bureau shall adopt regulations for the examining and licensing of
- 10 refrigeration technicians working on residential or light commercial refrigeration systems of less

- than ten tons. Licensing fees collected shall be placed in a retained revenue account to hire
- 12 qualified inspectors to enforce the provisions of this section.
- SECTION 3. This act shall take effect upon its passage.
