**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act authorizing the town of Lunenburg to grant an additional license for the sale of all alcoholic beverages not to be drunk on the premises to Jaxx Country Variety.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the  
2 licensing authority of the town of Lunenburg may grant 1 additional license for the sale of all  
3 alcoholic beverages not to be drunk on the premises pursuant to section 15 off said chapter 138  
4 to Jaxx Country Variety, located at 1353 Massachusetts Avenue. The license shall be subject to  
5 all said chapter 138 except said section 17.

6 (b) The licensing authority of the town of Lunenburg shall not approve the transfer of the  
7 license granted pursuant to this act to any other location but it may grant a license to a new  
8 applicant at the same location if the applicant files with the licensing authority a letter from the  
9 department of revenue and a letter from the department of unemployment assistance indicating  
10 that the license is in good standing with those departments and that all applicable taxes, fees and  
11 contributions have been paid.

12           (c) If a license granted pursuant to this act is cancelled, revoked or no longer in use at the  
13 location of original issuance, it shall be returned physically, with all of the legal rights, privileges  
14 and restrictions pertaining thereto, to the licensing authority and the licensing authority may  
15 grant the license to a new applicant at the same location under the same conditions as specified  
16 in this act.

17           SECTION 2. This act shall take effect upon its passage.
