**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act authorizing the city of Salem to convert a seasonal license for the sale of all alcoholic beverages to be drunk on the premises to an annual license for the sale of all alcoholic beverages to be drunk on the premises of Salem's Retreat at 96 North Street.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. (a) Notwithstanding section 17 of chapter 138 of the General Laws, the  
2           licensing authority of the city of Salem may convert a seasonal license for the sale of all  
3           alcoholic beverages to be drunk on the premises to an annual license for the sale of all alcoholic  
4           beverages to be drunk on the premises pursuant to section 12 of said chapter 138 to Salem's  
5           Retreat LLC d/b/a Salem's Retreat at 96 North Street. The license issued pursuant to this section  
6           shall be subject to all of said chapter 138, except said section 17.

7           (b) The licensing authority shall not approve the transfer of the license issued pursuant to  
8           this section to any other location but it may grant the license to a new applicant at the same  
9           location if the applicant for the license files with the licensing authority a letter from the

10 department of revenue and a letter from the department of unemployment assistance indicating  
11 that the license is in good standing with those departments and that all applicable taxes, fees and  
12 contributions have been paid.

13 (c) If the license issued pursuant to this section is cancelled, revoked or no longer in use  
14 at the location of original issuance, it shall be returned physically, with all of the legal rights,  
15 privileges and restrictions pertaining thereto, to the licensing authority and the licensing  
16 authority may then grant the license to a new applicant at the same location under the same  
17 conditions as specified in this section.

18 SECTION 2. (a) The city of Salem shall charge a fee for the license issued pursuant to  
19 this act that shall be paid by the licensee at the time of issuance unless the licensing authority  
20 agrees to enter into an arrangement with the licensee which would enable the fee to be divided  
21 into multiple payments or prorated over multiple periods of time. If the city elects to accept  
22 prorated payments over time from the licensee, the option shall be made available, upon request,  
23 to all qualified applicants for licensure.

24 (b) Any fee collected by the city of Salem for a license converted or granted pursuant to  
25 this act that is greater than the amount of the fee charged for an annual renewal of a similar  
26 license issued by the city shall be deposited into an economic development account which has  
27 been established by the city of Salem and expended by it in a manner consistent with the  
28 purposes of the account.

29 SECTION 3. This act shall take effect upon its passage.
