An Act providing technical education and economic opportunity for citizens with autism.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           (a) For purposes of this act, “autism spectrum disorder” shall have the same meaning as  
2 defined by the most recent edition of the Diagnostic and Statistical Manual of Mental Disorders.

3           (b) The Massachusetts Development Finance Agency and Mount Wachusett Community  
4 College shall develop a 3-year pilot program within 90 days of the effective date of this act to  
5 prepare individuals on the autism spectrum for careers in advanced technology machinery  
6 manufacturing. The pilot program shall be implemented by Mount Wachusett Community  
7 College, in collaboration with the Massachusetts Development Finance Agency, and shall  
8 include education and skills training for individuals with autism spectrum disorder relevant to  
9 advanced technology machinery manufacturing.

10           (c) The Massachusetts Development Finance Agency and Mount Wachusett Community  
11 College shall annually, not later than July 1, file a report with the clerks of the house of

12 representatives and the senate regarding outcomes for the pilot program, including, but not  
13 limited to: (i) total enrollment in the pilot program; (ii) graduation rates for individuals enrolled  
14 in the program; (iii) post-graduation employment statistics; (iv) the cost of running the pilot  
15 program on annual basis; and (v) the types of education and skills training provided by the pilot  
16 program.
