**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act providing for the city of Worcester school committee election.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The charter of the city of Worcester is amended as set forth herein to  
2 provide that all biennial local municipal elections for the city of Worcester school committee  
3 shall be conducted under a district and at-large system, hereinafter referred to as the hybrid  
4 system.

5 SECTION 2. Under the hybrid system, the city of Worcester shall be divided into 6  
6 school committee districts, of which at least 2 shall be majority-minority single member districts  
7 where Hispanic/Latino/a and Black residents together comprise a majority of the citizen voting  
8 age population. The hybrid system shall have two at-large seats elected by plurality voting. The  
9 district boundaries shall be drawn in consultation with an independent expert retained by the city  
10 pursuant to Paragraph R contained within the terms of the October 26, 2021 consent decree in  
11 the United States District Court of Massachusetts matter of Worcester Interfaith, Inc. et. al. v.  
12 City of Worcester et. al., Case No. 4:21-cv-40015-TSH.

13 SECTION 3. The Worcester Home Rule Charter, adopted by the voters in 1985, effective  
14 January 1, 1987 (“Worcester Home Rule Charter”) is amended by deleting Section 4-1(a) in its  
15 entirety and inserting in place thereof the following: -

16 (a) Composition: - The school committee shall consist of the mayor, who shall chair the  
17 committee, six district members and two members elected at-large.

18 SECTION 4. The Worcester Home Rule Charter is further amended by deleting Section  
19 4-1(c) in its entirety and inserting in place thereof the following: -

20 (c) Eligibility: -

21 (1) Any voter shall be eligible to hold the office of at-large school committee member  
22 provided, however, that the person shall have resided within the city for one year immediately  
23 prior to the election.

24 (2) Any voter shall be eligible to hold the office of a district school committee member  
25 provided, however, that the person shall have resided within the district for one year immediately  
26 prior to the election.

27 (3) For the 2023 school committee election only, if the school committee district  
28 boundaries have not been finalized by September 1, 2022, then the date by which a person must  
29 have been a resident of the district shall be sixty days following finalization of the school  
30 committee district boundaries.

31 (4) In the event that a district school committee member re-locates their residence to a  
32 different district within the city during their term of office, such school committee member will

33 be permitted to serve the remainder of their two-year term but will not be eligible for reelection  
34 in the same district.

35 SECTION 5. The Worcester Home Rule Charter is further amended by deleting the text  
36 of Section 4-6 in its entirety and inserting in place thereof the following: -

37 (a) At-large school committee member: -

38 If a vacancy shall occur amongst the two at-large members of the school committee, said  
39 vacancy shall be filled in the same manner as provided in section 2-10(a) for the filling of  
40 vacancies in the office of councilor-at-large, from among the candidates for election to the office  
41 of at-large school committee members at the preceding regular municipal election.

42 (b) District school committee member: -

43 If a vacancy shall occur in the office of district school committee member it shall be  
44 filled in the same manner as provided in section 4-6(a) for the office of at-large school  
45 committee member, except that the list shall be of the candidates for the office of district school  
46 committee member in the district in which the vacancy occurs, provided, however, if there be no  
47 candidate on such list who remains eligible and willing to serve, the vacancy shall be filled at a  
48 special election called by the city council to be held within ninety days after the city council is  
49 notified by the board of election commissioners that the vacancy cannot be filled as aforesaid.

50 SECTION 6. The Worcester Home Rule Charter is further amended by deleting Section  
51 7-4(b) in its entirety and inserting in place thereof the following: -

52 (b) Signature requirements:

53           The number of certified signatures of votes to appear on the petition accompanying the  
54 statement of a candidate for election to the office of councilor-at-large or school committee  
55 member-at-large shall be not less than three hundred. The number of certified signatures of  
56 voters from the district from which nomination is sought, required to appear on the petition  
57 accompanying the statement of a candidate for election to the office of district councilor or  
58 district school committee member, shall be not less than one hundred.

59           SECTION 7. The Worcester Home Rule Charter is further amended by deleting Section  
60 7-6(a) in its entirety and inserting in place thereof the following: -

61           (a) Number, requirements: -

62           (1) The board of election commissioners shall divide the city into five districts for the  
63 purpose of electing district councilors under Article 2 of this charter. Each such district shall be  
64 compact and shall contain, as nearly as may be, an equal number of inhabitants, shall be  
65 composed of

66           contiguous existing precincts, and shall be drawn with a view toward preserving the  
67 integrity of existing neighborhoods.

68           (2) The board of election commissioners shall divide the city into six districts for the  
69 purpose of electing district school committee members under Article 4 of this charter, of which  
70 at least 2 shall be majority-minority single member districts where Hispanic/Latino/a and Black  
71 residents together comprise a majority of the citizen voting age population. Each such district  
72 shall be compact and shall contain, as nearly as may be, an equal number of inhabitants, shall be  
73 composed of contiguous existing precincts, and shall be drawn with a view toward preserving the  
74 integrity of existing neighborhoods.

75           SECTION 8. The changes to the city of Worcester’s school committee electoral system  
76 as set forth in this act shall take effect for the city’s municipal elections in November of 2023.

77           SECTION 9. This act shall take effect upon its passage.
