By Mr. Hawkins of Attleboro, a petition (accompanied by bill, House, No. 4355) of James K. Hawkins, Adam J. Scanlon and Paul R. Feeney (with the approval of the mayor and city council) relative to providing for the laying out and acceptance of certain ways by the city of Attleboro. Municipalities and Regional Government. [Local Approval Received.]

The Commonwealth of Massachusetts

In the One Hundred and Ninety-Second General Court
(2021-2022)

An Act providing for the laying out and acceptance of certain ways by the city of Attleboro.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 the City of ATTLEBORO HEREBY petitions the general court of the Commonwealth of
2 Massachusetts to enact the following proposed special act:

3 AN ACT PROVIDING FOR THE LAYING OUT AND ACCEPTANCE OF CERTAIN
4 WAYS BY THE CITY OF ATTLEBORO

5 SECTION 1. Notwithstanding the provisions of any general or special law to the
6 contrary, the City of Attleboro is hereby authorized to lay out and accept as public ways any of
7 the ways listed in a document on file with the City Clerk.

8 The Planning Board for the City of Attleboro shall hold a public hearing on the issue of
9 the laying out and acceptance as public ways of those ways so listed within 6 months after the
10 effective date of this act, at which time interested persons shall be given an opportunity to be
11 heard.

12 Within 21 days after the public hearing, the Planning Board shall submit a
13 communication to the Municipal Council with its recommendation as to which ways so listed
14 should be and laid out and accepted as public ways by the City of Attleboro. The communication
15 from the Planning Board shall be referred to a standing committee of the Municipal Council or to
16 a special committee appointed by the Council President for the sole purpose of considering the
17 proposal to lay out and accept as public ways the ways so listed. Within 45 days of the referral
18 by the Planning Board, the Municipal Council shall hold a public hearing on the proposal.

19 At least 14 days before any such public hearing by the Municipal Council, written notice
20 of the intention of the city to lay out and accept as public ways and the intention to hold a public
21 hearing thereon shall be sent to the owners of land abutting or being a part of the ways so listed.
22 In addition, a notice of the city's intention to lay out and accept the ways so listed shall also be
23 published in a newspaper of general circulation in the city once in each of the two successive
24 weeks, the first publication to be not less than 14 days before any public hearing. The notice
25 shall also be posted on the bulletin board at the City Clerk's office for a period of not less than 14
26 days before a public hearing.

27 The standing or special committee shall report to the full Council within 14 days of the
28 public hearing with recommendations as to which ways so listed should and should not be laid
29 out and accepted as public ways by the City of Attleboro. The Municipal Council may then vote
30 to adopt, amend, or reject the proposal to lay out and accept as public ways any or all of the ways
31 listed.

32 Such vote by the Municipal Council shall be subject to the approval of the Mayor as
33 provided in Section 3(g) of the Attleboro City Charter. If the Mayor approves the vote, or if the

34 Municipal Council notwithstanding the Mayor's disapproval shall again adopt said proposal by a
35 two-thirds vote of the full Council, the ways contained in the final proposal shall be considered
36 laid out and shall be accepted as public ways.

37 SECTION 2. This act shall take effect upon its passage.
