The Commonwealth of Massachusetts

In the One Hundred and Ninety-Second General Court (2021-2022)

An Act relative to the Mashpee Select Board.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1	SECTION 1. Section 1-3 of the charter of the town of Mashpee on file with the office of
2	the state archivist as provided by section 12 of chapter 43B of the General Laws, is hereby
3	amended by striking out the words "board of selectmen" and inserting in place thereof in each
4	instance the following words:- select board.
5	SECTION 2. Section 1–7 of said charter hereby amended by striking out the definition of
6	"Board of Selectmen:" and inserting in place thereof the following definition:-
7	Select Board. The words "Select Board" shall mean the board of persons referred to in the
8	General Laws of Massachusetts and heretofore in this Charter as the Board of Selectmen."
9	SECTION 3. Section 2-5 of said charter is hereby amended by striking out the words
10	"board of selectmen" and inserting in place thereof in each instance the following words: - select
11	board.

12	SECTION 4. Section 2-6 of said charter is hereby amended by striking out the words
13	"board of selectmen" and inserting in place thereof in each instance the following words: - select

62	SECTION 21. Notwithstanding sections 21 and 32 of chapter 40 or section 5 of chapter
63	40A of the General Laws or any general or special law to the contrary, the board of selectmen of
64	the town of Mashpee may amend the general by laws and zoning by-laws of the town by
65	majority vote to revise all references to the board of selectmen and its members to select board
66	and select board member respectively.
67	SECTION 22. This act shall take effect upon its passage.
