**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act financing the general governmental infrastructure of the Commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. To provide for a program of capital investments for capital asset  
2 acquisitions, dispositions, public safety, governmental infrastructure, improvements to various  
3 state programs, services, agencies, institutions and properties, the sums set forth in this act, for  
4 the several purposes and subject to the conditions specified in this act, are hereby made  
5 available, subject to the laws regulating the disbursement of public funds, which sums shall be in  
6 addition to any other amounts previously appropriated for these purposes; provided, that the  
7 amounts specified for a particular project may be adjusted in order to facilitate projects  
8 authorized in this act.

12           0640-0307 For the Massachusetts Cultural Facilities Fund established in section 42 of

35 land and buildings and interests therein by purchase, prepayment of lease for a term that exceeds

37 of the General Laws, for the preparation of plans and specifications, disparity studies, repairs,  
38 construction, renovations, improvements, asset management, accessibility improvements,

49 delegation of project control and supervision process pursuant to section 5 of chapter 7C of the  
50 General Laws; provided further, that funds so transferred shall be distributed based on the  
51 severity of the need that the repair shall address and other criteria developed by the division, in  
52 consultation with the secretary of administration and finance ..... \$975,000,000

53           4000-2028 For costs associated with planning and studies, dispositions, acquisition of  
54 land and buildings and interests therein by purchase, prepayment of lease for a term that exceeds  
55 the useful life of the facility, gift or other transfer or by eminent domain pursuant to chapter 79  
56 of the General Laws, for the preparation of plans and specifications, repairs, construction,

57 renovations, improvements, modernization, construction, reconstruction, furnishing, equipping,  
58 acquiring, remodeling, refurbishing, asset management, accessibility improvements, demolition,  
59 disposition and remediation of facilities and grounds operated by the various departments within  
60 the executive office of health and human services, all as the commissioner of capital asset  
61 management and maintenance, in consultation with the secretary of health and human services  
62 and the appropriate commissioners of the departments within the executive office, shall consider  
63 appropriate; provided, that costs payable from this item shall include, but shall not be limited to,  
64 the costs of leases of temporary relocation space or equipment as required for completion of a  
65 project; provided further, that any federal reimbursement received by a state agency including,  
66 but not limited to, projects related to the provision of health care, human services, and veterans'  
67 services in connection with projects funded from this item may be retained by the executive  
68 office for administration and finance and expended for the purposes of the project, without  
69 further appropriation, in addition to the amounts appropriated in this  
70 item..... \$820,000,000

71 7066-2011 For costs associated with plans and specifications, planning and studies,  
72 repairs, reconstruction, demolition, remediation, rehabilitation, modernization, disposition,  
73 renovations, improvements and maintenance at Massachusetts public higher education campus  
74 facilities and grounds; provided, that all projects approved for design and construction by the  
75 division of capital asset management and maintenance shall be consistent in priority and need  
76 with regional capital master plans developed by the division of capital asset management and  
77 maintenance, in consultation, as applicable, with the presidents of the community colleges, state  
78 universities, and the University of Massachusetts and approved by the board of higher education,  
79 with respect to the community colleges and state universities, or approved by the board of

80 trustees of the University of Massachusetts, as applicable; provided further, that all maintenance  
81 and repair work funded by this item shall be included in the capital asset management  
82 information system administered by the division of capital asset management and maintenance

84 8000-2028 For costs associated with planning and studies, dispositions, acquisition of

131 chapter 121F; provided, that not less than 25 per cent shall be used to fund projects which  
132 preserve and produce housing for families and individuals with incomes of not more than 30 per

135 development has not spent the amount authorized under the bond cap for this program, at the end  
136 of each year following the effective date of this act, the department may award the remaining

143 property taxes or vacant or abandoned buildings, by waiving the requirements of this item and  
144 said chapter 121F, and by subsidizing the purchase price, borrowing costs or costs of renovation  
145 or new construction of 2 to 6 unit residential buildings for a person who shall own the property



146 and occupy any portion of the property as the person’s primary residence for at least 5 years  
147 from the date of purchase; provided further, that if more than 5 years, but less than 10 years,  
148 from the date the owner takes ownership of the property, the owner sells any of the owner’s  
149 interest in the property, the new owner shall so occupy 1 unit in the property for a period equal to  
150 the difference between 10 years and the amount of time the first owner occupied the property as  
151 the owner’s primary residence; provided further, that if the owner fails to so occupy a unit on the  
152 property or ceases to be the owner of the property as required by this section, the department  
153 shall recoup the value of any subsidy provided to the owner; and provided further, that 10 years  
154 after the owner takes possession of the property pursuant to this item, all restrictions on the

167 for the installation and use of such equipment, to establish, upgrade and expand career technical

182 0640-1005 For the water pollution abatement trust established in section 2 of chapter 29C  
183 of the General Laws for deposit in the Water Pollution Abatement Revolving Fund established in  
184 section 2L of chapter 29 of the General Laws for application by the trust to the purposes  
185 specified in section 5 of said chapter 29C, any portion of which may be used as a matching grant  
186 by the commonwealth to federal capitalization grants received under Title VI of the federal  
187 Clean Water Act or for deposit in the Drinking Water Revolving Fund established in section

197 assets by reducing or eliminating emissions from on-site use of fossil fuels, increasing energy  
198 and water efficiency, deploying renewable and clean energy resources, and improving resilience  
199 and climate change readiness, including costs associated with planning and studies, prepayment  
200 of lease for a term that exceeds the useful life of the facility, gifts or other transfers or by eminent  
201 domain under chapter 79 of the General Laws, for the preparation of plans and specifications,  
202 repairs, construction, renovations, improvements, asset management and demolition, disposition  
203 and remediation of state-owned and former county facilities and grounds, and repair and  
204 maintenance of buildings and building systems and equipment at various state-owned facilities;  
205 provided, that all maintenance and repair work funded in this item shall be listed in the capital  
206 asset management information system administered by the division of capital asset management  
207 and maintenance; provided further, that the commissioner of capital asset management and  
208 maintenance may, if appropriate, transfer funds in accordance with the delegation of project  
209 control and supervision process under section 5 of chapter 7C of the General Laws; provided  
210 further, that costs payable from this item shall include, but not be limited to, the costs of  
211 engineering and other services essential to these projects rendered by the division of capital asset

212 management and maintenance employees or by consultants; provided further, that amounts  
213 expended for employees of the division of capital asset management and maintenance may  
214 include the salary and salary-related expenses of such employees to the extent that such  
215 employees work on or in support of these projects; provided, however, that the division shall not  
216 expend more than 5 per cent of the funds authorized in this item for such costs; and provided  
217 further, that the commissioner of capital asset management and maintenance shall maximize  
218 efforts to utilize all available means to minimize use of capital funds to pay for salaries of

221 Department of Agricultural Resources

222 2511-0121 For a food security program, including grants to fund costs of immediate and  
223 projected infrastructure needs for farms, retailers, fisheries, food system businesses and food  
224 distribution channels including, but not limited to, food banks, farm stands, food hubs, food  
225 retailers, elder services and community supported agriculture farms, while taking into account  
226 the unique needs of rural and urban areas and gateway municipalities as defined in section 3A of  
227 chapter 23A of the General Laws, to provide greater access to local food, and to provide grants  
228 that support food banks and other parts of the food distribution channel by expanding services,  
229 which may include, but shall not be limited to: (i) information technology needs, including the  
230 development of online markets and delivery systems, including an online system to link food  
231 system channels to identify and match agricultural and fishery products to consumers and  
232 markets, particularly to benefit food insecure communities; (ii) facility adaptation to new safety  
233 guidelines, including new signage and the installation of handwashing stations; (iii) expansion of

234 storage and food preparation areas for food banks, food pantries or food distribution  
 235 organizations; (iv) the purchase or lease of point-of-sale devices to provide to retailers at no cost  
 236 to provide curbside pick-up and curbside payment service, including payment using electronic  
 237 benefits transfer cards; (v) storage and processing equipment to adapt to supply chain  
 238 disruptions, including for cold and ambient storage and vehicles for distribution; (vi) capital  
 239 support for food retailers in communities underserved by full grocery stores to increase capacity,  
 240 expand offerings of health foods and maintain continuity of business operations; (vii) production  
 241 processing and transportation for meat, fish and other poultry products individually, or through a  
 242 collaborative effort and information technology for tracking and quality control of products and  
 243 for fishing vessels and farms; and (viii) information technology needs for food retailers with not  
 244 more than 100 employees in order to meet criteria to join the online purchasing program of the  
 245 supplemental nutrition assistance program as outlined by the United States Department of

268 All such bonds issued by the commonwealth shall be designated on their face, General  
269 Governmental Infrastructure Act of 2022 and shall be issued for a maximum term of years, not  
270 exceeding 30 years, as the governor recommends to the general court pursuant to section 3 of  
271 Article LXII of the Amendments to the Constitution. The bonds shall be payable not later than  
272 June 30, 2057. All interest and payments on account of principal on these obligations shall be  
273 payable from the General Fund. Bonds and interest thereon issued pursuant to this section shall,  
274 notwithstanding any other provision of this act, be general obligations of the commonwealth.

275 SECTION 4. To meet the expenditures necessary in carrying out section 2C, the state  
276 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an  
277 amount to be specified by the governor, but not exceeding in the aggregate \$515,000,000. All  
278 such bonds issued by the commonwealth shall be designated on their face, General  
279 Governmental Infrastructure Act of 2022, and shall be issued for a maximum term of years, not  
280 exceeding 20 years, as the governor recommends to the general court pursuant to section 3 of  
281 Article LXII of the Amendments to the Constitution. The bonds shall be payable not later than  
282 June 30, 2047. All interest and payments on account of principal on these obligations shall be  
283 payable from the General Fund. Bonds and interest thereon issued pursuant to this section shall,  
284 notwithstanding any other provision of this act, be general obligations of the commonwealth.

285 SECTION 5. To meet the expenditures necessary in carrying out section 2D, the state  
286 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an  
287 amount to be specified by the governor, but not exceeding in the aggregate \$35,000,000. All  
288 such bonds issued by the commonwealth shall be designated on their face, General  
289 Governmental Infrastructure Act of 2022, and shall be issued for a maximum term of years, not  
290 exceeding 10 years, as the governor recommends to the general court pursuant to section 3 of  
291 Article LXII of the Amendments to the Constitution. The bonds shall be payable not later than  
292 June 30, 2037. All interest and payments on account of principal on these obligations shall be  
293 payable from the General Fund. Bonds and interest thereon issued pursuant to this section shall,  
294 notwithstanding any other provision of this act, be general obligations of the commonwealth.

295 SECTION 6. To meet the expenditures necessary in carrying out section 2E, the state  
296 treasurer shall, upon request of the governor, issue and sell bonds of the commonwealth in an  
297 amount to be specified by the governor from time to time but not exceeding, in the aggregate,

298 \$160,000,000. All such bonds issued by the commonwealth shall be designated on their face,  
299 General Governmental Infrastructure Act of 2022, and shall be issued for a maximum term of  
300 years, not exceeding 7 years, as the governor may recommend to the general court under section  
301 3 of Article LXII of the Amendments to the Constitution. The bonds shall be payable not later  
302 than June 30, 2034. All interest and payments on account of principal on these obligations shall  
303 be payable from the General Fund. Bonds and interest thereon issued under this section shall,  
304 notwithstanding any other provision of this act, be general obligations of the commonwealth.

305 SECTION 7. To provide for the continued availability of certain bond-funded spending

322 SECTION 8. To carry out the purposes of this act, the commissioner of capital asset  
323 management and maintenance may, notwithstanding sections 32 to 37, inclusive, of chapter 7C  
324 of the General Laws or any other general or special law to the contrary, acquire, by purchase,  
325 lease or leaseback for a term, including any extensions, not to exceed 50 years, gift or other  
326 transfer, or by eminent domain under chapter 79 of the General Laws, any interests in land and  
327 buildings considered necessary by the commissioner to carry out the purposes of this act  
328 including, but not limited to, easements for drainage, access, utilities and environmental  
329 mitigation, and may grant and retain such easements and interests as considered necessary by the  
330 commissioner to carry out the purposes of this act.

331 SECTION 9. Notwithstanding any general or special law to the contrary, funds  
332 authorized pursuant to sections 2 through 2E, inclusive, of this act shall only be expended for (i)  
333 the purposes specified in sections 2 through 2E, inclusive, of this act or (ii) for the purposes  
334 specified in the Fiscal Year 2022-2026 Five-Year Capital Investment Plan published by the  
335 governor and the executive office of administration and finance on June 14, 2021.
