An Act authorizing the conveyance of easements by the city of Fitchburg to the town of Westminster.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding any general or special law to the contrary, the city of  
2 Fitchburg may grant to the town of Westminster certain permanent roadway, drainage, utility and  
3 related easements and temporary construction easements, as such easements are described in  
4 section 3, in and to the parcels of land located in the town of Westminster described in section 2,  
5 for the Worcester Road (Route 140) reconstruction project.

6           SECTION 2. The parcels of land owned by the city of Fitchburg in and to which  
7 easements are authorized to be conveyed pursuant to section 1 are identified as parcels 186-1 and  
8 120-39 on the assessor’s map for the town of Westminster and described in deeds recorded with  
9 the Worcester registry of deeds in book 55, page 318; book 211, page 439; book 259, page 317;  
10 book 334, page 601; book 363, page 115; book 376, page 425, or however the same may have  
11 been acquired. The parcels, which were originally acquired for water supply purposes, are  
12 currently vacant.

13           SECTION 3. The permanent roadway, drainage, utility and related easements authorized  
14 to be conveyed to the town of Westminster pursuant to section 1, containing 2,000 square feet,  
15 more or less, in the aggregate, and the temporary construction easements to be conveyed to the  
16 town of Westminster pursuant to section 1, containing 13,000 square feet, more or less, in the  
17 aggregate, are approximately shown on plans entitled “Massachusetts Department of  
18 Transportation Highway Division Plan and Profile of Route 140 (Worcester Road)”, as may be  
19 amended, on file with the town clerk of the town of Westminster.

20           SECTION 4. In consideration of the easements authorized to be conveyed by the city of  
21 Fitchburg to the town of Westminster pursuant to section 1, the town of Westminster shall  
22 convey to the city of Fitchburg, for general municipal purpose use, the parcel of land located off  
23 Dawley road in said Westminster, currently held for general municipal purposes, and identified  
24 as parcel 123-19 on the assessor’s map for the town of Westminster, containing 27,878 square  
25 feet, and acquired by the town by instrument recorded in book 9460, page 187.

26           SECTION 5. This act shall take effect upon its passage.
