1           *Ordered,* That the committee on Public Service be authorized to sit during a recess of the  
2 General Court to make an investigation and study of House documents numbered 43, 61, 1304,  
3 2573, 2574, 2593, 2597, 2623, 2636, 2696, 2706, 2722, 2724, 2808 and 4170, relative to credible  
4 service, divestment, pensions, benefits and retirement.

5           Said committee shall report to the General Court the results of its investigation and study  
6 and its recommendations, if any, together with drafts of legislation necessary to carry such  
7 recommendations into effect, by filing the same with the Clerk of the House of Representatives  
8 on or before December 31, 2022.
