An Act relative to the number of all alcoholic beverage licenses in the town of Middleton.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Notwithstanding the provisions of section seventeen of chapter one hundred  
2   and thirty-eight of the General Laws, or any other general or special law or any rule or regulation  
3   to the contrary, the licensing authority of the town of Middleton is hereby authorized to issue  
4   eight (8) additional licenses for the sale of alcoholic beverages, as follows: two (2) licenses for  
5   the sale of all alcoholic beverages to be drunk off the premises; two (2) licenses for the sale of  
6   wine and malt beverages to be drunk off the premises; two (2) licenses for wine and malt  
7   beverages to be drunk on the premises under the provisions of section twelve of said chapter one  
8   hundred and thirty-eight; and two (2) seasonal licenses for the sale of wine and malt beverages.  
9   Said licenses shall be subject to all of the provisions of said chapter one hundred and thirty-eight  
10   except said section seventeen.

11           SECTION 2. This act shall take effect upon its passage.
