An Act relative to school operational efficiency.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 4 of chapter 30B of the General Laws, as appearing in the 2018  
2 Official Edition, is hereby amended by striking out subsection (a) and inserting in place thereof  
3 the following subsection:-

4 (a) Except as permitted pursuant to this section and section 7, for the procurement of a  
5 supply or service for a governmental body in the amount of \$10,000 or greater, but not more than  
6 \$50,000, a procurement officer shall seek written quotations from no fewer than 3 persons  
7 customarily providing the supply or service; provided, however, that for the procurement of a  
8 supply or service for a municipal or regional school district such amount shall be \$10,000 or  
9 greater, but not more than \$100,000. The procurement officer shall record: (1) the names and  
10 addresses of all person from whom quotations were sought, (2) the purchase description used for  
11 the procurement, (3) the names of the persons submitting quotations and (4) the date and amount  
12 of each quotation. Such information shall be retained in the file required pursuant to section 3. A  
13 governmental body may require that any procurement for a governmental body in an amount of

14 not more than \$50,000 be subject to section 5; provided, however, that any procurement for a  
15 municipal or regional school district such amount shall be not more than \$100,000.

16 SECTION 2. Section 5 of said chapter 30B, as so appearing, is hereby amended by  
17 striking out subsection (a) and inserting in place thereof the following subsection:-

18 (a) Except as permitted under section 6 or section 8, award of procurement contracts in  
19 the amount of more than \$50,000 provided, however, that award of procurement contracts for a  
20 municipal or regional school district in the amount of more than \$100,000, other than contracts  
21 for the procurement of real property, shall conform to the competitive sealed bidding procedures  
22 set forth in this section.

23 SECTION 3. Said section 5 of said chapter 30B, as so appearing, is hereby further  
24 amended by inserting after the figure “\$50,000”, in line 38, the following words:- and for a  
25 municipal or regional school district in the amount of more than \$100,000.

26 SECTION 4. Section 6 of said chapter 30B, as so appearing, is hereby amended by  
27 inserting after the figure “\$50,000’, in line 2, the following words:- and for a municipal or  
28 regional school district in the amount of more than \$100,000.

29 SECTION 5. Section 6A of said chapter 30B, as so appearing, is hereby amended by  
30 inserting after the figure “\$50,000’, in line 2, the following words:- and for a municipal or  
31 regional school district in the amount of more than \$100,000.

32 SECTION 6. Section 7 of said chapter 30B, as so appearing, is hereby amended by  
33 inserting after the figure “\$50,000’, in line 2, the following words:- and for a municipal or  
34 regional school district in the amount of more than \$100,000..

35 SECTION 7. Section 56 of chapter 41 of the General Laws is hereby amended by adding  
36 the following sentence:- This section shall not prohibit payment to be made for: (i) school travel  
37 prior to the date of travel, or (ii) the payment of software licenses, software maintenance  
38 agreements or online subscription services for school curriculum prior to the fiscal year in which  
39 services will be rendered.

40 SECTION 8. Section 53F ½ of chapter 44 of the General Laws, as so appearing, is hereby  
41 amended by inserting after the word “utility”, in line 4, the following words:- , school  
42 transportation service.

43 SECTION 9. Said section 53F ½ of said chapter 44, as so appearing, is hereby further  
44 amended by inserting after the word “enterprise”, in line 22, the following words:- ; provided,  
45 however, that the appropriate local entity for a school transportation service shall be the school  
46 committee.

47 SECTION 10. Section 49A of chapter 71 of the General Laws, as so appearing, is hereby  
48 amended by striking out, in lines 6 and 7, the words “, provided that no payment therefor shall be  
49 made prior to the commencement of said ensuing fiscal year” and inserting in place thereof the  
50 following words:- ; provided, that payment may be made prior to the commencement of said  
51 ensuing fiscal year.

52 SECTION 11. Said chapter 71 is hereby further amended by adding the following  
53 section:-

54 Section 98. Notwithstanding section 53 of chapter 44 or any general or special law to the  
55 contrary, a school district may establish a School Transportation Reimbursement Fund.  
56 Reimbursements made by the commonwealth pursuant to this section may be deposited into the

57 fund and may carry forward for 1 fiscal year. Funds received by a school district shall be  
58 deposited with the treasurer of the city or town and held as a separate account and expended by  
59 the school committee for the purposes of school transportation without further appropriation.

60 SECTION 12. Section 7D of chapter 90 of the General Laws, as appearing in the 2016  
61 Official Edition, is hereby amended by adding the following paragraph:-

62 An application for a license pursuant to this section shall be acted upon within 14 days of  
63 submission to the registry.
