*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 5 of Chapter 71B of the General Laws, as appearing in the 2016 Official  
2 Edition, is hereby amended by inserting the word "public," following the word "approved" in the  
3 second paragraph, line number 29, and further by deleting the language "April 1", in line number  
4 38, and replacing the same with the language "March 1".
