**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to assisting elders and people with disabilities in the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 1 of chapter 117A of the General Laws, as appearing in the 2018
2 Official Edition, is hereby amended by adding the following paragraph:- Any person
3 experiencing homelessness, (i) who has no established place of abode, or who lives in a
4 temporary emergency shelter, and (ii) who is otherwise eligible under the provisions of this
5 chapter, shall receive the same payment rate as recipients who incur shelter costs including, but
6 not limited to rent or a mortgage. The department shall promulgate or revise any such rules and
7 regulations necessary to implement the provisions of this section.

8 SECTION 2. Chapter 117A of the General Laws is hereby amended by inserting after
9 section 10 the following three sections:- Section 11. Effective July first of every year the
10 department shall increase the total budget of each eligible recipient, before taking into
11 consideration any available income and resources, by a percentage amount equal to the
12 percentage rise in the United States Consumer Price Index for January first of that year over the

13 level of said index for January first of the previous year plus such additional percentage amount
14 as is recommended annually by the department and appropriated by the general court. The
15 department shall promulgate such rules and regulations to implement the provisions of this
16 section.

17 Section 12. The combined countable assets of an assistance unit may not exceed \$2,500
18 for assistance units consisting of one person and \$5,000 for assistance units consisting of two or
19 more people. In determining countable assets, the department shall exclude the fair market value
20 of one vehicle;

21 Section 13. The department shall set the maximum benefit for the program in this chapter
22 at the same level as the program in chapter 118 of the General Laws. The department shall
23 promulgate such rules and regulations necessary to implement the provisions of this section.
