The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to preserving fertility.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 32A is hereby amended by inserting after section 17Q, inserted by
2 section 24 of chapter 208 of the acts of 2018 the following section:-

3 Section 17R. (a) Any coverage offered by the commission to an active or retired
4 employee of the commonwealth insured under the group insurance commission shall provide, to
5 the same extent that benefits are provided for other pregnancy-related procedures, coverage for
6 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
7 condition that may directly or indirectly cause (c) impairment of fertility by affecting
8 reproductive organs or processes. Said coverage will include the coverage for procurement,
9 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

10 (b) For the purposes of this section, “standard fertility preservation services” means
11 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
12 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
13 in accordance with current medical practices and professional guidelines published by the
14 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
15 other reputable professional organizations.

16 (c) For the purposes of this section, “may directly or indirectly cause” means that the
17 disease itself, or the necessary treatment, has a likely side effect of infertility as established by
18 the American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
19 other reputable professional organizations.

20 SECTION 2. Chapter 175 is hereby amended by inserting after section 47KK, inserted by
21 section 81 of chapter 208 of the acts of 2018 the following section:-

22 Section 47LL. (a) Any policy of accident and sickness insurance as described in section
23 108 that provides hospital expense and surgical expense insurance and that is delivered, issued or
24 subsequently renewed by agreement between the insurer and policyholder in the commonwealth;
25 any blanket or general policy of insurance described in subdivision (A), (C) or (D) of section 110
26 that provides hospital expense and surgical expense insurance and that is delivered, issued or
27 subsequently renewed by agreement between the insurer and the policyholder, within or without
28 the commonwealth; or any employees’ health and welfare fund that provides hospital expense
29 and surgical expense benefits and that is delivered, issued or renewed to any person or group of
30 persons in the commonwealth, shall provide to a commonwealth resident covered by the policy,
31 to the same extent that benefits are provided for other pregnancy-related procedures, coverage

32 for standard fertility preservation services (b) when the enrollee has a diagnosed medical or
33 genetic condition that may directly or indirectly cause (c) impairment of fertility by affecting
34 reproductive organs or processes. Said coverage will include the coverage for procurement,
35 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

36 (b) For the purposes of this section, “standard fertility preservation services” means
37 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
38 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
39 in accordance with current medical practices and professional guidelines published by the
40 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
41 other reputable professional organizations.

42 (c) For the purposes of this section, “may directly or indirectly cause” means that the
43 disease itself, or the necessary treatment, has a likely side effect of infertility as established by
44 the American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
45 other reputable professional organizations.

46 SECTION 3. Chapter 176A is hereby amended by inserting after section 8MM, inserted
47 by section 85 of chapter 208 of the acts of 2018 the following section:-

48 Section 8NN. (a) Any contract between a subscriber and the corporation under an
49 individual or group hospital service plan which is delivered, issued or renewed within the
50 commonwealth shall provide, to the same extent that benefits are provided for other pregnancy-
51 related procedures, coverage for standard fertility preservation services (b) when the enrollee has
52 a diagnosed medical or genetic condition that may directly or indirectly cause (c) impairment of

53 fertility by affecting reproductive organs or processes. Said coverage will include the coverage
54 for procurement, cryopreservation, and storage of gametes, embryos or other reproductive tissue.

55 (b) For the purposes of this section, “standard fertility preservation services” means
56 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
57 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
58 in accordance with current medical practices and professional guidelines published by the
59 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
60 other reputable professional organizations.

61 (c) For the purposes of this section, “may directly or indirectly cause” means that the
62 disease itself, or the necessary treatment, has a likely side effect of infertility as established by
63 the American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
64 other reputable professional organizations.

65 SECTION 4. Chapter 176B is hereby amended by inserting after section 4MM, inserted
66 by section 88 of chapter 208 of the acts of 2018 the following section:-

67 Section 4NN. (a) Any subscription certificate under an individual or group medical
68 service agreement delivered, issued or renewed within the commonwealth shall provide, to the
69 same extent that benefits are provided for other pregnancy-related procedures, coverage for
70 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
71 condition that may directly or indirectly cause (c) impairment of fertility by affecting
72 reproductive organs or processes. Said coverage will include the coverage for procurement,
73 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

74 (b) For the purposes of this section, “standard fertility preservation services” means
75 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
76 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
77 in accordance with current medical practices and professional guidelines published by the
78 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or

86 Section 4FF. (a) Any individual or group health maintenance contract shall provide, to
87 the same extent that benefits are provided for other pregnancy-related procedures, coverage for
88 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
89 condition that may directly or indirectly cause (c) impairment of fertility by affecting
90 reproductive organs or processes. Said coverage will include the coverage for procurement,
91 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

92 (b) For the purposes of this section, “standard fertility preservation services” means
93 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
94 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
95 in accordance with current medical practices and professional guidelines published by the

104 pregnancy-related benefits shall provide coverage, to the same extent that benefits are provided
105 for other pregnancy-related procedures, coverage for standard fertility preservation services (b)
106 when the enrollee has a diagnosed medical or genetic condition that may directly or indirectly
107 cause (c) impairment of fertility by affecting reproductive organs or processes. Said coverage
108 will include the coverage for procurement, cryopreservation, and storage of gametes, embryos or
109 other reproductive tissue.

110 (b) For the purposes of this section, “standard fertility preservation services” means
111 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
112 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
113 in accordance with current medical practices and professional guidelines published by the
114 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or
