The Commonwealth of Alassachusetts

In the One Hundred and Ninety-Second General Court (2021-2022)

An Act to promote safe dog ownership.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 Section 155 of Chapter 140 of the General Laws, as appearing in the 2016 Official
- 2 Edition, is hereby amended by striking the section in its entirety and inserting in place thereof the
- 3 following:
- 4 If any dog owner negligently permits their dog to cause damage to the property of any
- 5 person, including their pet, companion animal, or service animal, or to cause injury to any
- 6 person, then the owner or keeper thereof; or if the owner or keeper be a minor, the parent or
- 7 guardian of such owner or keeper thereof, shall be punished by a fine of not more than \$2,500.
- 8 A conviction or findings of sufficient facts on any charge brought under this section shall
- 9 be prima facie evidence of liability in any action brought in connection with the following:
- a. Any damage to any property, whether privately or publicly owned;

b. Any injury, illness, transmission of disease (such as rabies), or death to any person or animal which is reasonably attributable to or caused by a violation of this section;

But no such evidence of civil liability shall be found if such damage shall have been occasioned to the body or property of a person who, at the time such damage was sustained, was committing a trespass or other tort, or was teasing, tormenting or abusing such dog. If a minor, on whose behalf an action under this section is brought, is under seven years of age at the time the damage was done, there shall be a rebuttable presumption that such minor was not committing a trespass or other tort, or teasing, tormenting or abusing such dog.
