RE: Annual Report of Interceptions Made Pursuant to Massachusetts General Laws  
Chapter 272, Section 99

Dear Mr. Clerk:

In accordance with the provisions of Massachusetts General Laws Chapter 272, Section 99(R), the undersigned reports the following:

1. Number of applications for warrants made during 2020: 5 total, covering 4 phones:
  - a. 10/6/20: Initial warrant for two phone numbers (TT1 and TT2);
  - b. 10/21/20: Extension of TT1 and TT2. Addition of third number (TT3)
  - c. 11/5/20: End of TT1, TT2 and TT3. Add fourth number (TT4)
  - d. 11/20/20 Extension of TT4
  - e. 12/3/20 Extension of TT4
2. Name(s) of Applicants: District Attorney Michael Morrissey and specially designated Assistant District Attorneys Keith McCray, Michael McGee and Peter Tilley

3. Number of warrants issued:

- a) One warrant with one extension for TT1 and TT2
- b) One warrant for TT3 with no extensions
- c) One warrant with two extensions for TT4

Total of 3 warrants.

4. Effective periods of warrants:

- a. TT1 and TT2: 10/8/20 – 11/5/20
- b. TT3: 10/22/20 – 11/5/20
- c. TT4: 11/5/20 – 12/16/20

5. Number and designation of offenses:

The total number and designation of offenses is still being determined as some suspects have not yet been charged. Three suspects charged to date. Offenses include, but are not limited to Trafficking cocaine over 100 grams, trafficking in Class A (heroin/ fentanyl) over 100 grams, conspiracy to violate the drug laws, possession of firearm in commission of a felony, possession of a firearm with defaced serial number, possession of firearm without an FID card, possession of ammunition without FID card, possession of Class B drug with intent to distribute and possession of Class C drug with intent to distribute.


6. Total number of interceptions made during 2020: 8,254
