**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act relative to pregnancy loss awareness.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 111 of the General Laws is hereby amended by adding the following section:-

2 Section 244. (a) The commissioner shall develop and disseminate to the public  
3 information regarding pregnancy loss, including information on: (i) awareness of pregnancy loss  
4 and the incidence and prevalence of pregnancy loss among pregnant people; and (ii) the  
5 accessibility of the range of evidence-based treatment options, as medically appropriate, for  
6 pregnancy loss, including miscarriage and recurrent miscarriage, including but not limited to  
7 comprehensive mental health supports, necessary procedures and medications and culturally  
8 responsive supports such as pregnancy-loss doula care.

9 The commissioner may disseminate information to the public directly or through  
10 arrangements with agencies carrying out intra-agency initiatives, nonprofit organizations,  
11 consumer groups, community organizations, institutions of higher education or state or local  
12 public-private partnerships.

13 (b) The commissioner shall expand and coordinate programs for conducting and  
14 supporting evidence-based research with respect to causes of and current and novel treatment  
15 options and procedures for pregnancy loss.

16 (c) The commissioner shall, in consultation with and in accordance with guidelines from  
17 relevant medical societies, develop and disseminate to perinatal health care workers, including  
18 midwives, physician assistants, nurse practitioners, clinical nurse specialists and non-clinical  
19 perinatal health care workers, information on pregnancy loss for the purpose of ensuring that  
20 such perinatal health care workers remain informed about current information regarding  
21 pregnancy loss, including miscarriage and recurrent miscarriage, and prioritizing both the  
22 physical and mental health care of the patient. For purposes of this subsection, the term  
23 “perinatal health care worker” shall include any doula, community health worker, peer supporter,  
24 breastfeeding and lactation educator or counselor, nutritionist or dietitian, childbirth educator,  
25 social worker, home visitor, language interpreter or navigator.

26 (d) The commissioner shall, in a manner that protects personal privacy and complies with  
27 federal law, collect and assess data regarding pregnancy loss, including information  
28 disaggregated by race, ethnicity, health insurance status, disability, income level and geography  
29 on the prevalence of, the incidence of and knowledge about pregnancy loss.
