By Representative Wagner of Chicopee and Senator Lesser, a joint petition (accompanied by bill, House, No. 4860) of Joseph F. Wagner and Eric P. Lesser (with the approval of the mayor and city council) relative to voting precincts in the city of Chicopee. Election Laws. [Local Approval Received.]

**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act relative to voting precincts in the city of Chicopee.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Notwithstanding any general or special law to the contrary, ward 6 precinct
2 A of the city of Chicopee shall be 1 precinct for the purpose of forming congressional,
3 representative, senatorial or councilor districts, but shall have 2 polling places for the purpose of
4 voting at any federal, state, or municipal elections. One polling place shall be located to the south
5 of Champion drive and to the south of Westover Air Force Base boundary, to serve voters
6 residing in ward 6, precinct A, south of that drive and south of that boundary and shall be known
7 as ward 6, precinct AS. The other polling place shall be located to the north of Champion drive
8 and to the north of the Westover Air Force Base boundary, to serve voters residing in ward 6,
9 precinct A, north of that drive and north of that boundary and shall be known as ward 6, precinct
10 AN.

11 SECTION 2. Notwithstanding any general or special law to the contrary, ward 6, precinct
12 B in the city of Chicopee shall be 1 precinct for the purpose of forming congressional,

13 representative, senatorial or councilor districts but shall have 2 polling places for the purpose of
14 voting at any federal, state or municipal elections. One polling place shall be located to the east
15 of interstate highway route 291 and north of the Massachusetts turnpike to serve voters residing
16 in ward 6, precinct B in the Burnett road area and shall be known as ward 6, precinct BE. The
17 other polling place shall be located to the west of interstate highway route 291 and south of the
18 Massachusetts turnpike to serve voters residing in ward 6, precinct B in the Sheridan circle area
19 and shall be known as ward 6, precinct BW.

20 SECTION 3. The city clerk of the city of Chicopee and the board of registrars of the city
21 of Chicopee shall take all necessary actions to assure compliance with this act, including, but not
22 limited to, assuring the accuracy of the voting lists as located at each such polling place set forth
23 in sections 1 and 2. The city clerk and the board of registrars shall divide each of the precincts set
24 forth in sections 1 and 2 into 2 sub-precincts, in each of which is located 1 of the polling places
25 set forth in those sections, and only the names of voters who reside in each such sub-precinct
26 shall appear on the voting list for such sub-precinct.

27 SECTION 4. This act shall take effect upon its passage.
