An Act establishing a divorce task force.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           There is hereby established the Commonwealth divorce task force, whose purpose shall  
2 be to examine, evaluate, and analyze the system of divorce in Massachusetts, and to make any  
3 recommendations necessary to improve its efficiency and fairness, and to eliminate any adverse  
4 impacts on all parties affected by the system, including but not limited to, litigants and their  
5 children, attorneys, and the judges and staff of the probate and family court. The task force shall  
6 consider matters including but not limited to prenuptial agreements, mediation, division of  
7 assets, child custody, and the duration and efficiency of court and related proceedings.

8           The task force shall consist of the following members: 3 members appointed by the  
9 governor, each having knowledge and experience related to probate and family law in the state of  
10 Massachusetts, one of which shall be designated and serve as chair; 2 members appointed by the

11 president of the senate; 1 member appointed by the minority leader of the senate; 2 members  
12 appointed by the speaker of the house; 1 member appointed by the minority leader of the house;  
13 the attorney general or a designee; 1 member representing the Massachusetts bar association; 2  
14 members representing the probate and family court, appointed by the chief justice of the court; 1  
15 member representing the Massachusetts office of public collaboration; and 1 member  
16 representing the children's league of Massachusetts.

17           The task force shall file a report containing its findings and recommendations, including  
18 any draft legislation necessary to carry out its recommendations, with the clerks of the house of  
19 representatives and senate, the senate and house chairs of the joint committee on economic  
20 development and emerging technologies and the chairs of the house and senate committees on  
21 ways and means not later than June 31, 2022.
