An Act authorizing the town of Middleborough to convey certain conservation land in the town.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. The town of Middleborough, acting by and through its board of selectmen  
2 and conservation commission, may convey to Renee M. Andrews a parcel of conservation land  
3 in the town, which is part of Pratt farm and is included in a deed recorded with the Plymouth  
4 county registry of deeds in book 6673, page 151 containing 10,000 square feet of land being part  
5 of lot 3635 on the town of Middleborough assessor’s map 51 and shown as lot A on a plan  
6 entitled “28 Sachem Street, Middleborough, MA” dated February 19, 2021 prepared by Allen &  
7 Major Associates, Inc. recorded with the Plymouth registry of deeds in book 65, page 437.

8           SECTION 2. In exchange for the conveyance in section 1, the town of Middleborough  
9 board of selectmen and conservation commission shall accept for the town of Middleborough a  
10 parcel of land shown as lot B on a plan entitled “28 Sachem Street, Middleborough, MA” dated  
11 February 19, 2021 prepared by Allen & Major Associates, Inc. recorded with the Plymouth  
12 registry of deeds in book 65, page 437.

13           SECTION 3. The parcel described in section 2 shall be acquired by the town of  
14 Middleborough conservation commission for conservation purposes to be a part of Pratt farm  
15 under the management and control of the conservation commission.

16           SECTION 4. This act shall take effect upon its passage.
