4 Section 17R. (a) Any coverage offered by the commission to an active or retired
5 employee of the commonwealth insured under the group insurance commission shall provide, to
6 the same extent that benefits are provided for other pregnancy-related procedures, coverage for
7 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
8 condition that may directly or indirectly cause (c) impairment of fertility by affecting
9 reproductive organs or processes. Said coverage will include the coverage for procurement,
10 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

11 (b) For the purposes of this section, “standard fertility preservation services” means
12 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
13 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
14 in accordance with current medical practices and professional guidelines published by the
15 American Society for Reproductive Medicine, the American Society of Clinical Oncology, or

23 Section 47LL. (a) Any policy of accident and sickness insurance as described in section
24 108 that provides hospital expense and surgical expense insurance and that is delivered, issued or
25 subsequently renewed by agreement between the insurer and policyholder in the commonwealth;
26 any blanket or general policy of insurance described in subdivision (A), (C) or (D) of section 110
27 that provides hospital expense and surgical expense insurance and that is delivered, issued or
28 subsequently renewed by agreement between the insurer and the policyholder, within or without
29 the commonwealth; or any employees’ health and welfare fund that provides hospital expense
30 and surgical expense benefits and that is delivered, issued or renewed to any person or group of
31 persons in the commonwealth, shall provide to a commonwealth resident covered by the policy,
32 to the same extent that benefits are provided for other pregnancy-related procedures, coverage
33 for standard fertility preservation services (b) when the enrollee has a diagnosed medical or
34 genetic condition that may directly or indirectly cause (c) impairment of fertility by affecting
35 reproductive organs or processes. Said coverage will include the coverage for procurement,
36 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

50 individual or group hospital service plan which is delivered, issued or renewed within the
51 commonwealth shall provide, to the same extent that benefits are provided for other pregnancy-
52 related procedures, coverage for standard fertility preservation services (b) when the enrollee has
53 a diagnosed medical or genetic condition that may directly or indirectly cause (c) impairment of
54 fertility by affecting reproductive organs or processes. Said coverage will include the coverage
55 for procurement, cryopreservation, and storage of gametes, embryos or other reproductive tissue.

56 (b) For the purposes of this section, “standard fertility preservation services” means

70 same extent that benefits are provided for other pregnancy-related procedures, coverage for
71 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
72 condition that may directly or indirectly cause (c) impairment of fertility by affecting
73 reproductive organs or processes. Said coverage will include the coverage for procurement,
74 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

75 (b) For the purposes of this section, “standard fertility preservation services” means

88 the same extent that benefits are provided for other pregnancy-related procedures, coverage for
89 standard fertility preservation services (b) when the enrollee has a diagnosed medical or genetic
90 condition that may directly or indirectly cause (c) impairment of fertility by affecting
91 reproductive organs or processes. Said coverage will include the coverage for procurement,
92 cryopreservation, and storage of gametes, embryos or other reproductive tissue.

94 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician

106 for other pregnancy-related procedures, coverage for standard fertility preservation services (b)
107 when the enrollee has a diagnosed medical or genetic condition that may directly or indirectly
108 cause (c) impairment of fertility by affecting reproductive organs or processes. Said coverage
109 will include the coverage for procurement, cryopreservation, and storage of gametes, embryos or
110 other reproductive tissue.

111 (b) For the purposes of this section, “standard fertility preservation services” means
112 procedures or treatment to preserve fertility as recommended by a board-certified obstetrician
113 gynecologist, reproductive endocrinologist, or other physician, and this recommendation is made
