**The Commonwealth of Massachusetts**

**In the One Hundred and Ninety-Second General Court  
(2021-2022)**

An Act changing the name of the board of selectmen in the town of Wilmington to the select board.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 2 of chapter 592 of the acts of 1950 is hereby amended by striking  
2 out the word “selectmen” and inserting in place thereof the following words:- select board.

3           SECTION 2. Section 2A of said chapter 592, as inserted by section 1 of chapter 599 of  
4 the acts of 1981, is hereby amended by striking out the words “board of selectmen”, each time  
5 they appear, and inserting in place thereof the following words:- select board.

6           SECTION 3. The title of section 3 of said chapter 592 is hereby amended by striking out  
7 the word “Selectmen” and inserting in place thereof the following words:- Select Board  
8 Members.

9           SECTION 4. The first sentence of said section 3 of said chapter 592 is hereby amended  
10 by striking out the word “selectmen”, each time it appears, and inserting in place thereof, in each  
11 instance, the following words:- select board members.
