An Act for political party endorsement reform.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. The Massachusetts General Laws are hereby amended by inserting the

2 following new chapter:

3 Chapter 57A. Political Party Endorsement

4 Section 1. An Act to permit certain political party organizational reforms, by allowing a

5 cross-endorsement process, by which more than one political party, may endorse the

6 same

7 candidate, and all votes cast for that candidate, may be totaled for that particular

8 individual.

9 Section 2. Over many years, significant numbers of individuals have desired a greater

10 range of choices for electing public officials, during election periods. This legislation  
11 seeks to  
12 recognize that an additional choice would be provided, by permitting coalitions of  
13 different  
14 political designations, and parties, to support, and/or not support, various candidates.

15 Section 3. Present Massachusetts law requires independent, individual candidates by each  
16 political party, and/or independent persons. Votes presently, cannot be counted for a  
17 single  
18 individual, summed in total. In so doing, political choices are limited to certain  
19 definitions, that  
20 limit the ability of coalitions to form, that would improve voter choices.

21 Section 4. Other states have similar provisions, and have apparently found them to be  
22 useful, and appropriate.

23 Section 5. The Massachusetts Secretary of State, and its Elections Division, being the  
24 relevant regulator, and supervisor of elections in Massachusetts, is hereby empowered to  
25 establish appropriate regulations, by which all recognized political parties, may cross-  
26 endorse  
27 candidates of other parties, by their particular legal political process.
