An Act relative to pharmacy benefit managers.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 1 of chapter 6D of the General Laws, as appearing in the 2018  
2 Official Edition, is hereby amended by inserting after the definition "performance penalty" the  
3 following new definition:-

4 "Pharmacy benefit manager", a person, business or other entity, however organized, that  
5 directly or through a subsidiary provides pharmacy benefit management services for prescription  
6 drugs and devices on behalf of a health benefit plan sponsor, including, but not limited to, a self-  
7 insurance plan, labor union or other third-party payer; provided, however, that pharmacy benefit  
8 management services shall include, but not be limited to, the processing and payment of claims  
9 for prescription drugs, the performance of drug utilization review, the processing of drug prior  
10 authorization requests, pharmacy contracting, the adjudication of appeals or grievances related to  
11 prescription drug coverage contracts, formulary administration, drug benefit design, mail and  
12 specialty drug pharmacy services, cost containment, clinical, safety and adherence programs for  
13 pharmacy services and managing the cost of covered prescription drugs; provided further, that

14 “pharmacy benefit manager” shall include a health benefit plan that does not contract with a  
15 pharmacy benefit manager and manages its own prescription drug benefits unless specifically  
16 exempted by the commission.

17 SECTION 2. Chapter 6D of the General Laws, as appearing in the 2018 Official Edition,  
18 is hereby amended by inserting the following new section:-

19 Section 20: A health benefit plan or pharmacy benefit manager shall not penalize,  
20 require, or provide financial incentives, including variations in premiums, deductibles,  
21 copayments, or coinsurance, to insureds as incentives to use specific retail, mail order pharmacy,  
22 or other network pharmacy provider in which a pharmacy benefit manager has an ownership  
23 interest or that has an ownership interest in a pharmacy benefit manager.
