**In the One Hundred and Ninety-Second General Court
(2021-2022)**

An Act to establish the Bridge the Gap Scholarship to universalize access to community colleges.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 Section 16 of chapter 15A of the General Laws, as appearing in the 2018 Official Edition,
2 is hereby amended by inserting after the eleventh paragraph in that section, the following:-

3 There shall be a Bridge the Gap Scholarship Program to provide universal access for
4 residents of the Commonwealth to public higher education through accredited degree programs
5 offered at community college institutions under section 5 of this chapter. Such assistance shall
6 apply only after all other federal and state financial assistance has been exhausted. To be
7 eligible, students must have obtained a high school diploma, or its equivalent, from an institution
8 within the Commonwealth within the preceding two years, maintain a cumulative 2.5 grade point
9 average during their course of study, complete their course of study within three years, and agree

10 to reside and work within the Commonwealth for at least two years after graduation of such
11 course of study or further degree program within the Commonwealth. If a student does not fulfill
12 the above requirements, the scholarship will be converted into a low interest loan to be
13 determined and administered by the Department of Higher Education and Massachusetts
14 Education Financing Authority (MEFA) with exemptions for financial hardship.

15 Each community college shall annually consult with their Board of Trustees, local
16 workforce developments boards, and employers to identify current and future workforce needs
17 within such region. Upon identifying such workforce needs, the college shall certify up to five
18 programs eligible to qualify under the Bridge the Gap Scholarship Program to promote universal
19 access to higher education and workforce readiness. The college shall annually file with the
20 Department of Higher Education those programs certified to receive the Bridge the Gap
21 scholarship. The Department of Higher Education may promulgate regulations to implement this
22 section.
