An Act to eliminate the public counsel fee.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Subsection (f) of section 2A of chapter 211D of the General Laws is  
2 hereby amended by striking out in the first two sentences, each time it appears, the figure “\$150”  
3 and inserting in place thereof, in each instance, the following figure:- \$100.

4           SECTION 2. Subsection (f) of section 2A of chapter 211D of the General Laws is  
5 hereby amended by striking out in the first two sentences, each time it appears, the figure “\$100”  
6 and inserting in place thereof, in each instance, the following figure:- \$50.

7           SECTION 3. Section 2A of chapter 211D of the General Laws is hereby amended by  
8 striking out subsection (f), and inserting in place thereof the following subsection:-

9 (f) Notwithstanding any general or special law to the contrary, no person determined to  
10 be indigent shall be assessed a counsel fee.

11 SECTION 4. Section 1 of this act shall take effect on July 1, 2023.

12 SECTION 5. Section 2 of this act shall take effect on July 1, 2024.

13 SECTION 6. Section 3 of this act shall take effect on July 1, 2025.
