An Act creating the Massachusetts digital equity broadband adoption program.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 23A of the General Laws, as appearing in the 2018 Official  
2 Edition, is hereby amended by inserting after section 68 the following new section:-

3           Section 69. (a) There shall established within the executive office of housing and  
4 economic development a Massachusetts Digital Equity Broadband Adoption Program. The  
5 purpose of the program shall be to expand the availability of broadband internet connectivity  
6 throughout the commonwealth by providing financial assistance to eligible residents who cannot  
7 afford any available service.

8           (b) For the purposes of this section the following words shall have the following  
9 meanings unless the context clearly requires otherwise:

10           “Broadband service”, shall have the same meaning as defined in 7 C.F.R. § 1738.2.

11           “Provider”, a provider of broadband service in the commonwealth of Massachusetts.

12 (c) The office shall enter into an agreement with each provider under which the provider  
13 agrees to accept vouchers distributed by the office under this section as a form of payment for  
14 the provider's broadband internet service.

15 (d) In coordination with the department of elementary and secondary education, the  
16 office shall send information regarding the availability of financial assistance under this chapter  
17 to each family with students enrolled in kindergarten through twelfth grade. The information  
18 must include: (1) the name and contact information of each registered provider whose broadband  
19 Internet service is available in their school district; and (2) instructions for applying to the office  
20 for financial assistance under this section.

21 (e) An individual who receives information under subsection (d) may apply for financial  
22 assistance under this section in the manner specified by the office. Upon receipt of an  
23 application, the office shall determine: (1) the applicant's eligibility for financial assistance; (2)  
24 the amount of financial assistance for which the applicant is eligible; and (3) whether the  
25 applicant is eligible for a single payment or a recurring payment of financial assistance; based on  
26 the office's assessment of the applicant's need. (d) An applicant for financial assistance under this  
27 chapter: (1) who is receiving, or whose household includes an individual who is receiving,  
28 benefits under: (A) the Temporary Assistance for Needy Families (TANF) program; (B) the  
29 federal Supplemental Nutrition Assistance Program (SNAP); or (C) the Medicaid program; or (2)  
30 whose household includes a child who is eligible for free or reduced price lunch; is automatically  
31 eligible for financial assistance under this chapter.

32 (f) If the office determines that an individual is eligible for financial assistance under  
33 subsection (e), the office shall provide financial assistance to the individual in the form of 1 or

34 more vouchers, each in the amount of fifty percent of the subscription fee, that can be used by  
35 the individual to pay 1 or more of the following expenses: (i) Fees charged by a broadband  
36 provider for installation, activation, equipment purchase, WiFi extenders or other 1 time  
37 expenses of providing broadband Internet service to the individual; or (ii) fifty percent of the  
38 monthly subscription fees charged by a broadband Internet provider for the provision of  
39 broadband

40 Internet service to the individual, including modem and router charges. A voucher may  
41 be provided by the office in printed or electronic form.

42 (f) A registered broadband provider that receives a voucher under this section from an  
43 individual who subscribes to the provider's broadband Internet service shall deduct fifty percent  
44 of the amount owed by the subscriber for the provider's provision of broadband Internet service  
45 to the individual.

46 SECTION 2. Chapter 29 of the General Laws is hereby amended by inserting after  
47 section, the following new section:-

48 Section 2GGGGG. There shall be established a Broadband Adoption Digital Equity Fund  
49 to support providing residential internet service and related equipment and multilingual digital  
50 learning services to individuals through low-cost programs from both private broadband  
51 providers and federal assistance programs. The fund shall be administered by the secretary of  
52 housing and economic development. There shall be credited to the fund any revenue from  
53 appropriations or other money authorized by the general court and specifically designated to be  
54 credited to the fund and any gifts, grants, private contributions or investment income earned on  
55 the fund's assets and all other sources. Money deposited in the fund that is unexpended at the end

56 of the fiscal year shall not revert to the General Fund and shall be available for expenditure in the  
57 subsequent fiscal year and shall not be subject to section 5C.
