**RE: Annual Report of Wiretap Interceptions
To the General Court Pursuant to G.L. c. 272, § 99R**

Dear Mr. Welch:

Pursuant to the requirements set forth in General Laws Chapter 272, § 99R, I hereby submit this report to the General Court on behalf of the Hampden County District Attorney's Office for the calendar year of 2021.

The number of applications made for electronic surveillance warrants during 2021 totaled Eleven (11). The names of the applicant on each of these applications were District Attorney Anthony D. Gulluni, Assistant District Attorney Matthew Green, Assistant District Attorney Kerry Beattie and Assistant District Attorney Patrick Bennett. The Massachusetts Superior Court issued Twelve (12) wiretap warrants for separate target lines in 2021. The effective period for these warrants (which includes renewal warrants) during 2021 were:

- September 9, 2021 – October 7, 2021 (narcotics)
- May 7, 2021 – June 24, 2021 (narcotics and ABDW)

The number of designated offenses pertaining to these wiretap applications totaled One (1). These designated offenses are defined in G.L. c. 272, §99(B)(7) as the possession or sale of any narcotic or harmful drug and conspiracy thereof.

There were Seven (7) renewals for a warrant pertaining to the narcotics designated offenses in 2021.


