An Act relative to gender identity in insurance.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Section 1 of chapter 175 of the General Laws, as appearing in the 2020  
2 Official Edition, is hereby amended by inserting after the definition for "Foreign company", the  
3 following definition:-  
4           “Gender identity” shall mean a person's gender-related identity, appearance or behavior,  
5 whether or not that gender-related identity, appearance or behavior is different from that  
6 traditionally associated with the person's physiology or assigned sex at birth. Gender-related  
7 identity may be shown by providing evidence including, but not limited to, medical history, care  
8 or treatment of the gender-related identity, consistent and uniform assertion of the gender-related  
9 identity or any other evidence that the gender-related identity is sincerely held as part of a  
10 person's core identity; provided, however, that gender-related identity shall not be asserted for  
11 any improper purpose.

12 SECTION 2. Section 4C of chapter 175 of the General Laws, as so appearing, is hereby  
13 amended by inserting after the word “sex”, in line \_\_\_\_, the following words:- , gender identity.

14 SECTION 3. Section 24A of chapter 175 of the General Laws, as so appearing, is hereby  
15 amended by inserting after the word “sex ”, in line \_\_\_\_, the following words:- or gender identity.

16 SECTION 4. Section 120F of chapter 175 of the General Laws, as so appearing, is hereby  
17 amended by inserting after the word “sex”, in line \_\_\_\_, the following words:- , gender identity.

18 SECTION 5. Section 122 of chapter 175 of the General Laws, as so appearing, is hereby  
19 amended by inserting after the word “sex”, in line \_\_\_\_, the following words:- , gender identity,  
20 and after the word “sex” in line \_\_\_\_, the following words:- , or gender identity.

21 SECTION 6. This act shall take effect on January 1, 2024.
