## The Commonwealth of Massachusetts

In the One Hundred and Ninety-Third General Court (2023-2024)

An Act relative to determining capacity and invoking the health care proxy.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

| 6  | assigned to a patient, who has primary responsibility for the treatment and care of the patient, in |
| 7  | whatever setting medical diagnosis or treatment is rendered. Where more than one nurse              |
| 8  | practitioner shares such responsibility, any such nurse practitioner may act as the attending nurse |
| 9  | practitioner.   |
