In the One Hundred and Ninety-Third General Court (2023-2024)

An Act making technical changes to the laws regulating a certain notarial act.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 183 of the General Laws is hereby amended	ed by striking out section

2 42 and inserting in place thereof the following new section:

3 Section 42. The forms set forth in the appendix to this chapter and in section 15 of

4 chapter 222 for taking acknowledgments to deeds and other instruments and for certifying the

5 authority of officers taking proofs or acknowledgments may be used but the existence of those

6 forms shall not preclude the use of any other forms lawfully used as required or authorized by

7 any general or special law or any regulation or executive order regulating notaries public,

8 including forms that acknowledge the act of an individual executing a document in a

9 representative capacity but fail to acknowledge the deed or instrument as the act of the principal

10 or grantor.

SECTION 2. Section 1 of chapter 222 of the General Laws is hereby amended by striking
out the definition of "Acknowledgment" and inserting in place thereof the following:

"Acknowledgment", a notarial act in which an individual, at a single time appears, in person,
before a notary public, is identified by the notary public through satisfactory evidence of identity
and presents a document to the notary public and indicates that the individual has executed the
document for the purposes stated therein, and, if applicable, that the individual was authorized to
sign in a particular representative capacity and did so as the act of the person or entity stated
therein.

19 SECTION 3. Section 15 of said chapter 222 is hereby amended by striking out subsection20 (b) and inserting in place thereof the following subsection:

(b) A notary public shall take the acknowledgment of the signature or mark of persons
acknowledging for themselves or in any representative capacity by using substantially the
following form:

"On this _____day of ______, 20__, before me, the undersigned notary public,
(name of document signer) personally appeared, proved to me
through satisfactory evidence of identification, which were ______, to be
the person whose name is signed on the preceding or attached document, and acknowledged to
me that (he) (she) signed it for its stated purpose.

36	"voluntary or free" from the third numbered paragraph of subsection (b).

39	SECTION 6. Form 14, as set forth in the appendix to chapter 183 of the General Laws, is
