By Representative Nguyen of Andover, a petition (accompanied by bill, House, No. 2004) of Tram T. Nguyen that the Department of Public Health establish a special task force on alcohol and drug free housing to investigate best practices for alcohol and drug free sober homes. Mental Health, Substance Use and Recovery.

In the One Hundred and Ninety-Third General Court
(2023-2024)

An Act to establish a special task force on best practices for sober homes.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 18A of Chapter 17 of the General Laws, as appearing in the 2020
2 official edition, is hereby amended by inserting after the words “best practices”, in line 28, the
3 following words:-

4 ", comply with standards of best practice as established by rules and regulations
5 promulgated pursuant to this section,"

6 SECTION 2. Said section 18A of said Chapter 17 of the General Laws is hereby further
7 amended by adding the following subsection:-

8 (i) The department of public health shall establish a special task force on alcohol and
9 drug free housing to investigate best practices for alcohol and drug free housing in the
10 commonwealth, including but not limited to; (i) the presence of on-site supervisors; (ii) access to
11 treatment; (iii) proper medication dispensing practices; (iv) local zoning control over such

12 housing; and (v) persons released on probation for drug-related offenses and ordered to reside in
13 such housing, including the recidivism rate of such persons and the role of the probation officers
14 and the sheriff's department in the process of monitoring such persons after their release to such
15 housing. The department shall promulgate rules and regulations establishing standards of best
16 practice for alcohol and drug free housing based on the results of the investigation conducted by
17 the task force. Only those facilities that meet these standards shall be authorized to be known as
18 "sober homes."
