**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act expanding wheelchair protection for consumers with disabilities.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 93 of the General Laws, as appearing in the most recent edition, is
2 hereby amended by inserting after section 107 the following new section:-

3 Section 107A.

4 (a) As set forth in this section, the term “authorized wheelchair supplier” shall mean, any
5 seller of a wheelchair that supplies products and services of complex rehabilitation technology
6 equipment.

7 The term “complex rehabilitation technology wheelchair” shall mean, a specialized,
8 medically necessary, and individually configured manual or power wheelchair. The provision of
9 this specialized equipment requires evaluation, configuration, fitting, adjustment, and
10 programming along with long-term maintenance and repair services.

11 (b) Prior authorization for any repair of a complex rehabilitation technology wheelchair
12 shall not be required by any payor.

13 (c) (1) Any authorized wheelchair supplier that provides a complex rehabilitation
14 technology wheelchair shall be required to repair said product in a timely manner within
15 Massachusetts. Pursuant to this subsection, the Department of Public Health shall establish
16 standards for repairing complex rehabilitation technology wheelchairs in a timely manner and the
17 expected quality of each repair. Prior to promulgating any standards or regulations pursuant to
18 this subsection, the Department of Public Health shall engage in a stakeholder process, which
19 process shall include qualified complex rehabilitation technology professionals, authorized
20 wheelchair suppliers, and complex rehabilitation technology consumers. This stakeholder
21 process will be used to develop the metrics for timeliness and quality of repair

22 (2) The department shall enforce existing regulations in regards to authorized wheelchair
23 suppliers servicing equipment they sell within the commonwealth

24 (3) The Department of Public Health shall develop an attestation statement that the
25 authorized wheelchair supplier shall submit affirming that the authorized wheelchair supplier is
26 compliant with the applicable repair and service requirements through the department's
27 enrollment and revalidation process.

28 (d) The Department of MassHealth in conjunction with the Division of Insurance shall
29 establish a fee schedule to reimburse authorized wheelchair suppliers for the evaluation and
30 diagnosis of complex rehabilitation technology wheelchair repairs.

31 (e) This section shall take effect six months after the effective date in order for any
32 regulations necessary to effectuate its purpose to be promulgated.
