By Representatives Lewis of Framingham and Domb of Amherst, a petition (accompanied by bill, House, No. 2224) of Jack Patrick Lewis, Mindy Domb and others relative to improving healthcare delivery for underserved residents. Public Health.

The Commonwealth of Massachusetts

**In the One Hundred and Ninety-Third General Court
(2023-2024)**

An Act improving healthcare delivery for underserved residents of the Commonwealth.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Section 9 of Chapter 112 of the General Laws, as appearing in the 2020
2 Official Edition, is hereby amended by inserting a parenthetical lowercase arabic numeral “a”,
3 before the words “an applicant” in the first sentence.

4 SECTION 2. Said section 9 of chapter 112 of the General Laws is -hereby further
5 amended by inserting at the end thereof, the following subsection:-

6 (b) Notwithstanding the other provisions of this section, an internationally-trained
7 physician who has been licensed or otherwise authorized to practice medicine in a country other
8 than the United States shall be eligible to apply for a limited license to practice medicine for a
9 renewable one-year term after satisfying the criteria in below paragraph 2, provided, however,
10 that such limited registration shall provide a pathway for the issuance of a full unrestricted
11 license to practice medicine in accordance with, and upon satisfaction of, the criteria in below
12 paragraph 4.

13 (1) Definitions. For the purposes of this subsection, the following terms shall have the
14 following meanings—

15 (i) “ECFMG” shall mean the Educational Commission for Foreign Medical Graduates.

16 (ii) “Internationally-trained physician” shall mean a physician who has received a degree
17 of doctor of medicine or its equivalent from a legally chartered medical school outside the
18 United States recognized by the World Health Organization, who has been licensed or otherwise
19 authorized to practice medicine in a country other than the United States, and who has practiced
20 medicine for at least one year.

21 (iii) “Massachusetts physician shortage area” shall mean a geographic region or
22 population in the commonwealth experiencing a shortage of physicians, especially primary care
23 physicians or psychiatrists, relative to population and need, as determined by the board.

24 (iii) “Participating healthcare facility” shall mean a federally-qualified health center,
25 community health center, hospital, or other healthcare facility approved by the board that
26 provides an assessment and evaluation program designed to develop, assess, and evaluate an
27 internationally-trained physician’s non-clinical skills, according to criteria developed or
28 approved by the board; provided, however, that the participating healthcare facility provides
29 medical care in a Massachusetts physician shortage area.

30 (iv) “USMLE” shall mean United States Medical Licensure Exam.

31 (2) The board shall issue a limited license to an applicant if the participating facility and
32 the applicant submit evidence acceptable to the board that the applicant:

33 (i) is an internationally-trained physician;

34 (ii) has a valid certificate issued by the ECFMG or other credential evaluation service
35 approved by the board, provided, however, that the board may waive such certification at its
36 discretion where the applicant is unable to obtain the required documentation from a non-
37 cooperating country;

38 (iii) has achieved a passing score on each of Steps 1 and 2 CK of the USMLE;

39 (iv) has entered into an agreement with the participating facility providing that the facility
40 shall develop, assess and evaluate the applicant's familiarity with non-clinical skills and
41 standards appropriate for medical practice in the commonwealth, according to assessment and
42 evaluation criteria developed or approved by the board;

43 (v) will enter a full-time full employment relationship with the participating facility after
44 the board issues a limited license to practice medicine to the applicant; and

45 (vi) has satisfied other criteria that may be developed by the board in fulfillment of this
46 subsection.

47 (3) The 1-year limited license may be renewed once, for a total 2-year term of limited
48 registration.

49 (4) An internationally-trained physician who provides the board with proof of (i)
50 successful completion of the participating facility's assessment and evaluation program, and (ii)
51 a passing score on Step 3 of the USMLE, shall be eligible to apply for a renewable 2-year
52 restricted license to practice medicine only in a Massachusetts physician shortage area
53 designated by the board; provided, however, that such license shall authorize the holder to
54 practice independently in a primary care specialty, psychiatry, or other specialty approved by the

55 board. After 2 to 4 years of such restricted practice, the internationally-trained physician shall be
56 eligible to apply for a full, unrestricted license to practice medicine.
