An Act relative to dental service quotes.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 111 of the General Laws is hereby amended by inserting after section 228 the  
2 following section:-

3 Section 228½. (a) As used in this section, the following terms shall, unless the context  
4 clearly requires otherwise, have the following meanings:-

5 “Board”, the board of registration in dentistry established pursuant to section 19 of  
6 chapter 13.

7 “Dental services”, diagnostic, preventative or corrective treatment of the teeth and  
8 associated structures of the oral cavity, including, but not limited to, oral surgery and the  
9 provision of orthodontia and prostheses.

10           “Dental services provider”, a provider of dental services, including, but not limited to, a  
11 dentist registered by the board pursuant to section 45 of chapter 112, a dental hygienist registered  
12 by the board pursuant to section 51 of said chapter 112, a dental assistant register by the board  
13 pursuant to section 51½ of said chapter 112 or an oral and maxillofacial surgeon certified by the  
14 American Board of Oral and Maxillofacial Surgery.

15           (b) Upon request by a patient or prospective patient, a dental services provider shall  
16 provide a quote of the costs associated with any dental services prior to performing any dental  
17 services; provided, however, that if a patient or prospective patient schedules a series of  
18 procedures or services as part of a continued course of treatment, the patient or prospective  
19 patient may waive the requirement to receive such quote from the dental services provider for  
20 that course of treatment.

21           (c) If a dental services provider completes any dental services without providing the  
22 patient with a quote pursuant to subsection (b), the patient may file a complaint with the board.  
23 Upon receipt of a complaint pursuant to this section, the board shall conduct an investigation into  
24 whether the completed dental services were medically necessary. If, as a result of such  
25 investigation, the board has reasonable cause to believe that the completed dental services were  
26 not medically necessary, it shall file a written report of the violation with the attorney general  
27 who shall, within 3 months following receipt of such report, notify the board in writing of the  
28 action taken with respect to such violation.
