**In the One Hundred and Ninety-Third General Court  
(2023-2024)**

An Act enabling trained dental hygienists to administer dermal fillers and botox.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Section 51 of chapter 112 of the General Laws, as appearing in the 2020  
2 Official Edition, is hereby amended by inserting after the first instance of the words “adopted by  
3 the board,” the following:

4 “A dental hygienist, under the direct supervision of a supervising dentist, may administer  
5 botulinum toxins and or dermal fillers, provided they have received the same prescribed  
6 additional training in the administration of botulinum toxins and or dermal fillers as that of a  
7 dentist and approved by the board. A dental hygienist shall not administer botulinum toxins and  
8 or dermal fillers independently of a dentist.”
