## The Commonwealth of Alassachusetts

In the One Hundred and Ninety-Third General Court (2023-2024)

An Act relative to culturally competent and effective health care.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- SECTION 1. Chapter 111 of the Massachusetts General Laws shall be amended by

The Center for Health Information and Analysis shall report on the data 24 collected under this section to the House and Senate Clerk and the Department of Public Health no later than January 30th of each calendar year. 25 26 SECTION 3. This act shall become effective 90 days after enactment.
