An Act relative to fire safety education in schools and colleges.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1           SECTION 1. Chapter 15A of the General Laws is hereby amended by adding the  
2 following section:- “Section 46. Establishment of a fire safety curriculum. (a) For the purposes of  
3 this section, the following term shall, unless the context clearly requires otherwise, have the  
4 following meaning:- “Institute of higher education”, all postsecondary institutions including: (i)  
5 the system of public institutions of higher education, established in section 5; (ii) private  
6 occupational schools, as defined in section 263 of chapter 112; and (iii) private colleges,  
7 universities and other institutions of higher learning.

8           (b) All institutes of higher education shall require students to complete a comprehensive  
9 fire safety curriculum from an expert source. The curriculum shall include instruction on fire  
10 safety in a variety of scenarios, such as: fire prevention, fires in homes, in professional settings,

11 in vehicles, wild and brush fires, fires while cooking, while camping, electrical fires, heating  
12 fires, smoking fires, solid, liquid and gas fires, smoldering fires, fast-burning fires, smoke  
13 inhalation, carbon monoxide poisoning, and leaving a fire scene, and any other matter the  
14 institution deems essential to the curriculum. Students shall complete an examination to test  
15 student proficiency.

16 SECTION 2. Chapter 71 of the General Laws is hereby amended by adding the following  
17 section:- “Section 98. Establishment of a fire safety curriculum. (a) For the purposes of this  
18 section, the following term shall, unless the context clearly requires otherwise, have the  
19 following meaning:- “School”, every public or private elementary and secondary school in the  
20 commonwealth; provided, however, that the term school shall not include colleges and  
21 universities.

22 (b) All schools shall require students to complete a comprehensive fire safety curriculum  
23 by the end of the 10th grade from an expert source. The curriculum shall include instruction on  
24 fire safety in a variety of scenarios, such as: fire prevention, fires in homes, in professional  
25 settings, in vehicles, wild and brush fires, fires while cooking, while camping, electrical fires,  
26 heating fires, smoking fires, solid, liquid and gas fires, smoldering fires, fast-burning fires,  
27 smoke inhalation, carbon monoxide poisoning, and leaving a fire scene, and any other matter the  
28 institution deems essential to the curriculum. Students shall complete an examination to test  
29 student proficiency.
