**In the One Hundred and Ninety-Third General Court  
(2023-2024)**

An Act relative to the equitable merger of the Group 4 and Group 2 retirement classifications of the University of Massachusetts police.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Group 4 of paragraph (g) of subdivision (2) of section 3 of chapter 32 of the  
2 General Law, as appearing in the 2018 Official Edition, is hereby amended by striking out, in  
3 lines 327 and 328, the words:- ; "chief of security for the University of Massachusetts medical  
4 school or supervisory identification agent,".

5 SECTION 2. Group 4 of said paragraph (g) of said subsection (2) of said section 3 of  
6 chapter 32 as so appearing, is hereby further amended by adding after the words "parole officer,"  
7 in lines 327 and 328, the following words:- "chief of police for the University of Massachusetts  
8 medical school and police officers of the University of Massachusetts as defined in section 1 of  
9 chapter 6E,".

10           SECTION 3. Group 2 of paragraph (g) of subdivision (2) of section 3 of chapter 32 of the  
11 General Laws, as so appearing, is hereby amended by striking out, in lines 253 and 254, the  
12 words:- "University of Massachusetts police,".
