### The Commonwealth of Alassachusetts

In the One Hundred and Ninety-Third General Court (2023-2024)

An Act relative to rolling stock.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

- 1 SECTION 1. Section 1 of chapter 64H of the General Laws, as appearing in the 2020
- 2 Official Edition, is hereby amended by inserting, after the definition of "Retail establishment",
- 3 the following definition:-
- 4 "Rolling stock", trucks, tractors, and trailers, used by common carriers to transport goods
- 5 in interstate commerce.
- 6 SECTION 2. Section 6 of chapter 64H, as so appearing, is hereby amended by inserting,
- 7 after subsection (xx), the following new subsection:-
- 8 (yy) Sales of rolling stock.
- 9 SECTION 3. Section 1 of chapter 64I, as so appearing, is hereby amended by inserting in
- line 7, after the words "retail establishment", the following new words:- ", rolling stock".

- SECTION 4. Section 7 of chapter 64I, as so appearing, is hereby amended by inserting,
- 12 after subsection (e), the following new subsection:-
- 13 (f) Storage, use or other consumption of rolling stock."
