By Representative Howard of Lowell, a petition (accompanied by bill, House, No. 3052) of Vanna Howard and others for legislation to create a permanent commission on the status of people who practice Islam. State Administration and Regulatory Oversight.

**The Commonwealth of Massachusetts**

In the One Hundred and Ninety-Third General Court  
(2023-2024)

An Act promoting the civil rights and inclusion of American Muslims in the Commonwealth.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 SECTION 1. Chapter 3 of the General Laws is hereby amended by adding the following  
2 section:-

3 Section 71. (a) There shall be a permanent commission on the status of people who  
4 practice Islam consisting of 11 persons as follows: 2 persons appointed by the governor; 1 person  
5 appointed by the speaker of the house of representatives; 1 person appointed by the president of  
6 the senate; 1 person appointed by the attorney general; 2 persons appointed by the state  
7 secretary; 2 persons appointed by the senate chair of the Massachusetts general court’s joint  
8 committee on racial equity, civil rights, and inclusion; and 2 persons appointed by the house  
9 chair of the Massachusetts general court’s joint committee on racial equity, civil rights, and  
10 inclusion. Members of the commission shall reside in the commonwealth who have  
11 demonstrated a commitment to the Muslim American community. Members shall be subject to  
12 the provisions of chapter 268A as they apply to special state employees.

13 (b) Members shall serve terms of 3 years and until their successors are appointed.  
14 Vacancies in the membership of the commission shall be filled by the original appointing  
15 authority for the balance of the unexpired term. Nominations for members shall be solicited by  
16 the appointing authorities between August 1 and September 16 of each year through an open  
17 application process using a uniform application that is widely distributed throughout the state.

18 (c) The commission shall elect from among its members a chair, a vice chair, a treasurer  
19 and any other officers it considers necessary. The members of the commission shall receive no  
20 compensation for their services, provided however, that they shall be reimbursed for any usual  
21 and customary expenses incurred in the performance of their duties.

22 (d) The commission shall be a resource to the commonwealth on issues affecting  
23 American Muslim communities in the commonwealth. In furtherance of that responsibility, the  
24 commission shall: (1) promote research and serve as a clearinghouse and source of information  
25 on issues pertaining to American Muslims in the commonwealth; (2) inform the public and  
26 leaders of business, education, human services, health care, state and local governments and the  
27 communications media of the unique cultural, social, ethnic, economic and educational issues  
28 affecting American Muslims in the commonwealth; (3) foster unity among the American Muslim  
29 community and organizations in the commonwealth by promoting cooperation and sharing of  
30 information and encouraging collaboration and joint activities; (4) serve as a liaison between  
31 government and private interest groups with regard to matters of unique interest and concern to  
32 American Muslims in the commonwealth; (5) identify and recommend qualified American  
33 Muslims for appointive positions at all levels of government, including boards and commissions,  
34 as the commission considers necessary and appropriate; (6) assess programs and practices in all  
35 state agencies as they affect American Muslims, as the commission considers necessary and

36 appropriate; (7) advise executive and legislative bodies on the potential effect on American  
37 Muslims of proposed legislation, as the commission considers necessary and appropriate; and (8)  
38 generally undertake activities designed to enable the commonwealth to realize the full benefit of  
39 the skills, talents and cultural heritage of American Muslims in the commonwealth.

40 (e) The commission shall annually, on or before June 2, report the results of its findings  
41 and activities of the preceding year and its recommendations to the governor and to the clerks of  
42 the senate and house of representatives.

43 (f) The powers of the commission shall include, but not be limited, to: (1) using the  
44 voluntary and uncompensated services of private individuals, agencies and organizations that  
45 may from time to time be offered and needed, including the provision of meeting places and  
46 refreshments; (2) holding regular, public meetings and holding fact-finding hearings and other  
47 public forums as it considers necessary; (3) directing staff to perform its duties; (4) establishing  
48 and maintaining offices that it considers necessary, subject to appropriation; (5) enacting by-laws  
49 for its own governance that are not inconsistent with any general or special law; and (6)  
50 recommending policies and making recommendations to agencies and officers of the state and  
51 local subdivisions of government to effectuate the purposes of subsection (d).

52 (g) The commission may request from all state agencies whatever information and  
53 assistance the commission requires.

54 (h) The commission may accept and solicit funds, including any gifts, donations, grants,  
55 or bequests, or any federal funds for any of the purposes of this section. These funds shall be  
56 deposited in a separate account with the state secretary's office, be received by the state secretary  
57 on behalf of the commonwealth, and be expended by the commission in accordance with law.

58 (i) The commission staff shall consist of a paid executive director, employees and  
59 volunteers who assist the commission in effecting its statutory duties. The commission shall  
60 appoint the executive director for a term of 3 years.

61 SECTION 2. Notwithstanding section 1, the initial members of the American Muslim  
62 commission shall be appointed for the following terms:-

63 (a) The governor shall appoint, on or before December, 1, 2024 2 members, each for a  
64 term of 3 years.

65 (b) The attorney general shall appoint, on or before December 1, 2024, 1 member for a  
66 term of 3 years.

67 (c) The speaker of the house of representatives shall appoint, on or before December 1,  
68 2024, 1 member for a term of 3 years.

69 (d) The president of the senate shall appoint, on or before December 1 2024, 1 member  
70 for a term of 3 years.

71 (e) The state secretary shall appoint, on or before December 1, 2024, 2 members, each for  
72 a term of 3 years.

73 (f) The chair of the Senate committee on racial equity, civil rights shall appoint, on or  
74 before December 1, 2024, 2 members, each for a term of 3 years.

75 (g) The chair of the House committee on racial equity, civil rights shall appoint, on or  
76 before December 1, 2024, 2 members, each for a 3 year term.

77           SECTION 3. The executive director of the American Muslim commission, established by  
78 section 1, shall initially be appointed by the commissioners for the term of 3 years on or before  
79 December 1, 2025.

80           SECTION 4. Sections 1 to 3, inclusive, shall take effect on December 1, 2024.
