By Representative Blais of Deerfield, a petition (subject to Joint Rule 12) of Natalie M. Blais relative to establishing a state disaster relief fund for emergency management. Emergency Preparedness and Management.

The Commonwealth of Massachusetts

In the One Hundred and Ninety-Third General Court
(2023-2024)

An Act creating a state disaster relief fund for emergency management.

Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:

1 SECTION 1. Chapter 29 of the General Laws is hereby amended by inserting after
2 section 2AAAAAA the following section:-

3 Section 2BBBBBB. There is hereby established and set up on the books of the
4 commonwealth a separate fund to be known as the Disaster Relief Trust Fund. There shall be
5 credited to the fund: (i) money appropriated or transferred to the fund, including money
6 transferred pursuant to section 5G of chapter 29; (ii) funds from public or private sources
7 specifically designated for the purposes of this section, including, but not limited to, gifts, grants,
8 donations, rebates and settlements received by the commonwealth; and (iii) any income derived
9 from investment of amounts credited to the fund.

10 Amounts credited to the fund shall not be subject to further appropriation and money
11 remaining in the fund at the end of a fiscal year shall not revert to the General Fund. The fund
12 shall retain all interest earned on sums deposited in the fund. The fund shall not have a deficit.

13 The fund shall be administered by the Massachusetts emergency management agency,
14 which shall expend money from the fund to provide emergency disaster relief and alleviate the
15 damage, loss, hardship, or suffering caused by a natural or human-caused disaster or other
16 catastrophic event, including, but not limited to, a hurricane, tornado, storm, rain, flood, tidal
17 wave, earthquake, volcanic eruption, landslide, mudslide, snowstorm, extreme heat, fire or
18 drought, including when a federal or state disaster declaration has not been made, or to
19 supplement funding related to a federal or state disaster declaration.

20 The Massachusetts emergency management agency shall create 1 or more programs to
21 implement this section and shall develop program administration regulations and guidance which
22 shall include, but not be limited to, an application procedure and eligibility criteria for the
23 distribution of monies from the fund. Program regulations and guidance shall take into account
24 existing federal and commonwealth disaster relief and recovery programs and requirements and
25 shall prioritize utilization of available federal disaster relief and recovery programs.

26 Payments may be made to municipalities, private non-profit organizations, businesses,
27 and individual residents of the commonwealth as the director determines appropriate. Payments
28 may be distributed as reimbursements, grants, matching funds, cost share payments, or as
29 determined by the director.

30 An annual report, which shall include expenditures made, their amounts, recipients and
31 the reason for the expenditure, as well as income received by the fund, shall be submitted to the
32 clerks of the house of representatives and the senate and to the house and senate committees on
33 ways and means not later than December 31 of each year.

34 SECTION 2. The second sentence of section 5G of chapter 29 of the General Laws is
35 hereby amended by inserting after the words “established in section 2H” the following words:- ;
36 provided, that before transferring funds pursuant to this clause, the comptroller shall, at the start
37 of each fiscal year, transfer sufficient funds under this paragraph so that the balance in the
38 Disaster Relief Trust Fund established in section 2BBBBBB of chapter 29 is no less than \$250
39 million as of that date.

40 SECTION 3: Not more than 180 days after the effective date of this act, the
41 Massachusetts emergency management agency shall submit to the house and senate chairs of the
42 joint committee on emergency preparedness and management, the house and senate chairs of the
43 joint committee on the environment and natural resources, the house and senate chairs of the
44 joint committee on agriculture, and the chair of the senate committee on global warming and
45 climate change a comprehensive report outlining the program or programs to be developed under
46 this act and how the program or programs will be implemented, including:

47 (1) an overview of the process for each program to be developed, including, but not
48 limited to,

49 (i) the thresholds and eligibility criteria for qualifying events and applicants for relief;

50 (ii) the process for making exceptions; and

51 (iii) the application submission and approval process;

52 (2) statutory or regulatory changes necessary to allow timely expenditures of funds in
53 cases of emergency, and

54 (3) the agency's needs to effectively implement the program or programs, including
55 budgets and employees.
