In the One Hundred and Ninety-Third General Court  
(2023-2024)

An Act relative to student representative voting rights.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

1 Chapter 71 Section 38M of the General Laws, as appearing in the 2020 official edition, is  
2 hereby amended by striking the words “Said chairperson shall be an ex-officio, nonvoting  
3 member of the school committee, without the right to attend executive sessions unless such right  
4 is expressly granted by the individual school committee. Said chairperson shall be subject to all  
5 school committee rules and regulations and shall serve without compensation.” in lines 9 through  
6 14 and inserting in their place the following:

7 “School committees of cities, towns and regional school districts shall recognize two (2)  
8 student representatives, to be elected by the student bodies of all secondary schools within the  
9 district, prior to the first day of June in each year. Said representatives shall be allowed to vote  
10 on all matters before the committee. Student representatives shall be subject to all school  
11 committee rules and regulations, shall serve without compensation, and without the right to

12 attend executive sessions unless such right is expressly granted by the individual school  
13 committee.

14           There shall also be a student advisory committee with members numbered as determined  
15 by the district, to be elected by the students of the secondary school or schools within the district.  
16 The purpose of said student advisory committee will be to assist the elected student  
17 representatives with their regular duties and to assist their constituents with accessing resources  
18 as well as connecting students with the student representatives.”
